2	To adopt Joint Rule No. 11 of the Joint Rules of the Senate and House of Representatives
3	to provide relative to the appointment of the members of the House Committee on
4	Ways and Means and of the Senate Committee on Revenue and Fiscal Affairs.
5	BE IT RESOLVED by the Legislature of Louisiana that Joint Rule No. 11 of the
6	Joint Rules of the Senate and House of Representatives is hereby adopted to read as follows:
7	Joint Rule No. 11. Membership; House Committee on Ways and Means; Senate
8	Committee on Revenue and Fiscal Affairs
9	A. In appointing the members of the House Committee on Ways and Means
10	in accordance with House Rule 6.3 of the Rules of Order of the House of
11	Representatives, the Speaker of House of Representatives shall appoint at least two
12	members who reside in each respective district for the election of members to the
13	State Board of Elementary and Secondary Education.
14	B. In appointing the members of the Senate Committee on Revenue and
15	Fiscal Affairs in accordance with Senate Rule 13.1 of the Rules of Order of the
16	Senate, the President of the Senate shall appoint at least one member who resides in
17	each respective district for the election of members to the State Board of Elementary
18	and Secondary Education.
19	BE IT FURTHER RESOLVED that this Concurrent Resolution shall become
20	effective if and when either House Bill No. 90 or House Bill No. 122 of this 2018 Regular
21	Session is enacted and becomes effective. If both House Bill No. 90 and House Bill No. 122

Abstract: Requires the speaker of House of Representatives to appoint at least two members from each BESE district to the House Committee on Ways and Means and for the president of the Senate to appoint at least one member from each BESE district to the Senate Committee on Revenue and Fiscal Affairs.

<u>Present House Rule</u> (House Rule 6.3) provides that no standing committee, except Appropriations, shall be composed or more than 18 members, excluding the chairman. Provides that the members of each standing committee, except Appropriations, shall be appointed by the speaker.

<u>Present Senate Rule</u> (Senate Rule 13.1) provides that the Senate Committee on Revenue and Fiscal Affairs is composed of 11 members appointed by the president.

<u>Proposed Joint Rule</u> provides that in appointing the members of the House Committee on Ways and Means in accordance with the <u>present House Rule</u>, the speaker shall appoint at least two members from each district for the election of members to the State Bd. of Elementary and Secondary Education (BESE) and provides that in appointing the members of the Senate Committee on Revenue and Fiscal Affairs in accordance with Senate Rule 13.1 of the Rules of Order of the Senate, the president shall appoint at least one member from each BESE district.

Effective if and when either House Bill No. 90 or House Bill No. 122 of the 2018 Regular Session is enacted and becomes effective; if both bills are enacted and become effective, the Concurrent Resolution becomes effective on July 1, 2018.
