| 7 | Be it enacted by the Legislature of Louisiana: |
| 8 | Section 1. R.S. 47:463.196 is hereby enacted to read as follows: |
| 9 | §463.196. Special prestige license plate; "Seymore D'Fair Foundation One Hundred |
| 10 | Percent Me Drug Free" |
| 11 | A. The secretary of the Department of Public Safety and Corrections shall |
| 12 | establish a special prestige motor vehicle license plate to be known as the "Seymore |
| 13 | D'Fair Foundation One Hundred Percent Me Drug Free" plate, provided there is a |
| 14 | minimum of one thousand applicants for such plate. The plate shall be restricted to |
| 15 | use on passenger cars, pickup trucks, recreational vehicles, motorcycles, and vans. |
| 16 | B. The secretary shall work in conjunction with the Seymore D'Fair |
| 17 | Foundation to select the color and design of the plate, provided it is in compliance |
| 18 | with R.S. 47:463(A)(3). The design shall include the words "Seymore D'Fair |
| 19 | Foundation One Hundred Percent Me Drug Free". |
| 20 | C. The special prestige license plate shall be issued, upon application, to any |
| 21 | citizen of Louisiana in the same manner as any other motor vehicle license plate. |
| 22 | D. The department shall collect an annual royalty fee of twenty-five dollars |
| 23 | that shall be disbursed in accordance with Subsection E of this Section. This fee |
| 24 | shall be in addition to the standard motor vehicle license tax imposed by Article VII, |

| 5 | to the Seymore D'Fair Foundation. The monies received from the royalty fees shall |
| 6 | be dedicated to drug prevention education in elementary and middle schools in the |
| 7 | state of Louisiana. |
| 8 | F. The secretary shall promulgate and adopt rules and regulations as are |
| 9 | necessary to implement the provisions of this Section. |
