In Senate Committee Amendment No. 3, proposed by the Senate Committee on Labor and Industrial Relations and adopted by the Senate on May 10, 2018, on line 27, delete "<u>similar</u> <u>wearing</u>" and insert "<u>other</u>" and, on line 35, delete "<u>turgid</u>" and insert "<u>erect</u>" and delete line 38 and insert "(a) oral, anal, or vaginal sexual intercourse" and on line 39, delete "<u>Excretory</u>" and insert "<u>Emission</u>" and between lines 40 and 41 insert "(c) Masturbation."

On page 3, line 28, after "Employee" insert "or independent contractor"

AMENDMENT NO. 3

Delete Amendment No. 4, proposed by the Senate Committee on Labor and Industrial Relations and adopted by the Senate on May 10, 2018.

2 On page 4, delete lines 1 through 11, and insert the following:

3	"A. The operator of a sexually oriented business shall verify the age and
4	work eligibility status of each employee and potential employee by requiring that at
5	least one document from both Paragraph (1) and (2) of this Subsection be produced.
6	(1) In combination with any document listed in Paragraph (2) of this
7	Subsection, any one of the following documents shall be produced:
8	(a) A valid current Louisiana driver's license that contains a photograph of
9	the person presenting the driver's license.
10	(b) A valid current driver's license of another state that contains a photograph
11	and the date of birth of the person submitting the driver's license.
12	(c) A valid current special identification card issued by the state of Louisiana
13	pursuant to R.S. 40:1321 containing a photograph of the person submitting the
14	identification card.
15	(d) A valid current special identification card issued by another state
16	containing a photograph and the date of birth of the person submitting the
17	identification card.
18	(e) A valid current passport or visa issued by the federal government or
19	another country or nation, that contains a permanently attached photograph and the
20	date of birth of the person submitting the passport or visa.
21	(f) A valid current military or federal identification card issued by the federal
22	government containing a photograph and the date of birth of the person submitting
23	the identification card.
24	(2) In combination with any document listed in Paragraph (1) of this
25	Subsection, any one of the following documents shall be produced:
26	(a) Verification through the United States Citizenship and Immigration
27	Services E-Verify program. or by ensuring proper completion of Form I-9,
28	Employment Eligibility Verification, for each employee or potential employee with
29	a completed and signed Internal Revenue Service W-2 form.
30	(b) A verified social security number with a completed and signed Internal
31	Revenue Service W-2 form.
32	B. The operator of a sexually oriented business shall verify the age and work
33	eligibility status of each independent contractor and potential independent contractor
34	by requiring that at least one document from both Paragraph (1) and (2) of this
35	Subsection be produced.

1	(1) In combination with any document listed in Paragraph (2) of this
2	Subsection, any one of the following documents shall be produced :
3	(a) A valid current Louisiana driver's license that contains a photograph of
4	the person presenting the driver's license.
5	(b) A valid current driver's license of another state that contains a photograph
6	and the date of birth of the person submitting the driver's license.
7	(c) A valid current special identification card issued by the state of Louisiana
8	pursuant to R.S. 40:1321 containing a photograph of the person submitting the
9	identification card.
10	(d) A valid current special identification card issued by another state
11	containing a photograph and the date of birth of the person submitting the
12	identification card.
13	(e) A valid current passport or visa issued by the federal government or
14	another country or nation, that contains a permanently attached photograph and the
15	date of birth of the person submitting the passport or visa.
16	(f) A valid current military or federal identification card issued by the federal
17	government containing a photograph and the date of birth of the person submitting
18	the identification card.
19	(2) In combination with any document listed in Paragraph (1) of this
20	Subsection, any one of the following documents can be produced:
21	(a) A verified social security number with a completed and signed Internal
22	Revenue Service Form W-9.
23	(b) A United States Citizenship and Immigration Services Form I-9 List A
24	document or one United States Citizenship and Immigration Services Form I-9 List
25	B document and C document and a completed and signed Internal Revenue Service
26	<u>Form W-9.</u>
27	C. No form of identification required by Subsection A or B of this Section
28	shall be accepted as proof of identification if it is expired, defaced, mutilated, or
29	altered. If the state identification card or lawful identification submitted is a
30	duplicate, the person shall submit additional identification that contains the name,
31	date of birth, and photograph of the person. A duplicate driver's license shall be
32	considered lawful identification for the purposes of this Section, and a person shall
33	not be required to submit additional information containing the name, date of birth,
34	and picture of the person."
