9	11:2220(C)(4) is hereby enacted to read as follows:

12	C. Refund of contributions, application and payment.

14	(4)(a) Notwithstanding any other provision of law to the contrary, excep
15	Subparagraph (b) of this Paragraph, any member whose first employment
16	making him eligible for membership in this system occurred prior to January 1
17	2013, who receives a refund of all contributions as provided for in this
18	Subsection and who returns to employment making him eligible for
19	membership in this system shall enter the system as a new member withou
20	regard to the dates of prior membership.
21	(b) Notwithstanding the eighteen-month waiting period in R.S.
22	11:2218(G), any member whose first employment making him eligible for
23	membership in this system occurred prior to January 1, 2013, who received a
24	refund of all contributions as provided for in this Subsection before June 30
25	2018, who returns to employment making him eligible for membership in this
26	system shall be immediately eligible to obtain credit for his previous service in

1 the system. The member may reestablish the previous service under the plan 2 provisions that applied to the member on the date he received his refund by 3 repaying the refund with interest calculated as provided in R.S. 11:2218(G) 4 within one year of returning to employment covered by this system. If the 5 member repays the refund at any time thereafter, the provisions of Subparagraph (a) of this Paragraph shall apply. 6 7 §2241.3. Eligibility for plan membership 8 9 A. Membership in this subplan is limited to employees who, notwithstanding 10 any temporal restrictions and any training program certified and required by the 11 Peace Officer Standards and Training Council relative to qualifying for such pay, 12 would be eligible to receive state supplemental pay by virtue of their employment. 13 14 Section 2. This Act shall become effective on June 30, 2018; if vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on 15 16 June 30, 2018, or on the day following such approval by the legislature, whichever is later.
