HOUSE RESOLUTION NO. 240

HEALTH/LDH: Requests the Louisiana Department of Health to raise awareness about the risks posed by atrial fibrillation and stroke

A RESOLUTION

2	To urge and request the Louisiana Department of Health to raise awareness concerning the
3	risks posed by atrial fibrillation and stroke.
4	WHEREAS, according to the National Heart, Lung and Blood Institute, atrial
5	fibrillation is the most common type of arrhythmia; and
6	WHEREAS, while an estimated two million seven hundred thousand to six million
7	one hundred thousand people in the United States have atrial fibrillation, this number is
8	expected to increase with the aging of the population; and
9	WHEREAS, risk factors for atrial fibrillation include high blood pressure, heart
10	failure, diabetes, advanced age, hyperthyroidism, and heart disease; and
11	WHEREAS, those with atrial fibrillation have a risk of stroke that is four times
12	greater than those without, and strokes caused by complications from atrial fibrillation tend
13	to be more severe than strokes with other underlying causes; and
14	WHEREAS, stroke is the fifth leading cause of death in the United States resulting
15	in one person in the United States dying from stroke every four minutes; and
16	WHEREAS, stroke is the leading cause of long-term disability and stroke survivors
17	are most likely to become disabled and experience difficulties with daily living and
18	activities; and
19	WHEREAS, the total annual cost of stroke in the United States is thirty-four billion
20	dollars, which includes direct healthcare costs and lost productivity; and

1	WHEREAS, atrial fibrillation is a serious health issue deserving attention from state
2	health officials; and
3	WHEREAS, an increase in community awareness of atrial fibrillation and its
4	complications can improve the likelihood that people with atrial fibrillation will seek the
5	treatment they need before suffering from devastating consequences.
6	THEREFORE, BE IT RESOLVED that the House of Representatives of the
7	Legislature of Louisiana does hereby urge and request the Louisiana Department of Health
8	to raise awareness about the risks posed by atrial fibrillation and stroke, as well as the
9	availability of treatment options.
