"Sale or purchase of water for residential use by the 17 consumer" includes the furnishing of water to single private residences, including the 18 19 separate private units of apartment houses and other multiple residential dwellings, where the water is actually used for residential purposes, irrespective of whether the 20 21 resident or a person other than the resident is contractually bound to the supplier for 22 the charges, actually pays the charges, or is billed for the charges. "Water for residential use" shall not include any water in bottles, jugs, or other containers. 23
