2 On page 1, line 9, delete "**registration and**"

6 On page 2, line 1, after "**filed**" change "**on or**" to "**for an income tax period beginning**
7 **before January 1, 2018, or for a franchise tax period beginning**"

8 AMENDMENT NO. 4

9 On page 2, line 2, after "**shall**" delete "**not**" and delete lines 3 and 4 and insert "**include only**
10 **credits receiving priority pursuant to R.S. 47:1675(B)(3) and (4) and shall not include**
11 **credits allowed to be carried forward pursuant to R.S. 47:297.4(B)(2) or R.S.**
12 **47:6104(C).**"

14 On page 2, line 6, delete "**registered**" and insert "**recorded**"

16 On page 2, line 9, delete "**redeemed**" and insert "**utilized**"

4 **after January 1, 2018, and before January 1, 2019, or the franchise tax period**
5 **beginning on or after January 1, 2019, and before January 1, 2020.**"

6 AMENDMENT NO. 14

7 On page 3, lines 11 and 12, delete "**or registered on or before November 15, 2019**" and
8 insert "**as provided in this Subparagraph**"

9 AMENDMENT NO. 15

10 On page 3, at the end of line 14, insert "**The secretary shall not grant an exception unless**
11 **the exception is first approved by the Joint Legislative Committee on the Budget.**"

12 AMENDMENT NO. 16

13 On page 3, delete lines 17 and 18, and on line 19, delete "**balance to carry forward, no**
14 **registration is required.**" and insert "**claim the full tax credit balance on a return for the**
15 **income tax period beginning on or after January 1, 2018, and before January 1, 2019,**
16 **or the franchise tax period beginning on or after January 1, 2019, and before January**
17 **1, 2020.**"

19 On page 3, line 20, delete "**or registered**"

20 AMENDMENT NO. 18

21 On page 3, at the end of line 23, insert "**The secretary shall not grant an exception unless**
22 **the exception is first approved by the Joint Legislative Committee on the Budget.**"

23 AMENDMENT NO. 19

24 On page 3, line 24, change "**(5)**" to "**(4)**"

25 AMENDMENT NO. 20

26 On page 4, line 4, change "**pursuant to the provisions of**" to "**by any lawful means,**
27 **including those provided in**"

28 AMENDMENT NO. 21

29 On page 4, line 8, after "**access.**" and before "**Information**" insert "**(1)**"

30 AMENDMENT NO. 22

31 On page 4, between lines 11 and 12, insert the following:

32 **"(2) Notwithstanding the provisions of Paragraph (1) of this Subsection,**
33 **the secretary shall include in the tax exemption budget the following**
34 **information:**

35 **(a) The number of businesses which receive each tax credit.**

36 **(b) The parish or location of each business which receives a tax credit;**
37 **provided, that if fewer than ten businesses receive a particular tax credit, the**
38 **tax exemption budget may group such tax credit with another tax credit which**
39 **also has fewer than ten businesses receiving it.**

40 **(c) The information shall be displayed in a manner that identifies:**

1 (i) The industry group by North American Industry Classification
2 System sector.

3 (ii) The number of taxpayers by industry.

4 (iii) The total tax burden by industry group by individual tax before the
5 credit.

6 (iv) The total value to each industry group for each credit.

7 (v) The total tax value by each industry group by individual tax of the
8 tax collections after the credit.

9 (3) The items contained in Paragraph (2) of this Subsection shall be
10 published to the extent that the information is available to the department, on
11 a schedule to be determined by the secretary of the department, and fully
12 implemented by the date of publication of the Fiscal Year 2018-2019 tax
13 exemption budget on or before March 1, 2020. The secretary shall ensure that
14 the publication shall not include confidential information."

15 AMENDMENT NO. 23

16 On page 4, line 14, after "Section." and before "The" insert "In addition to submitting the
17 proposed rules to the appropriate standing committees of the legislature as required
18 by the Administrative Procedure Act, the proposed rules shall be submitted to the Joint
19 Legislative Committee on the Budget for approval prior to the rules being
20 promulgated."

21 AMENDMENT NO. 24

22 On page 4, line 15, change "Paragraph (C)(4)" to "Paragraph (C)(3)"
