TRAFFIC/VIOLATIONS: Provides with respect to the use of a wireless telecommunications device while operating a motor vehicle

AN ACT

2	To amend and reenact R.S. 32:300.5 and to repeal R.S. 32:300.6, 300.7, and 300.8, relative
3	to the use of certain wireless telecommunications devices while operating a motor
4	vehicle; to provide for definitions; to provide for exceptions; and to provide for
5	related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 32:300.5 is hereby amended and reenacted to read as follows:
8	§300.5. Use of certain wireless telecommunications devices for text messaging and
9	social networking prohibited
0	A.(1) Except as provided in Subsection B of this Section, no person shall
1	operate any motor vehicle upon any public road or highway of this state while using
12	a wireless telecommunications device to write, send, or read a text-based
13	communication. For purposes of this Section, a person shall not be deemed to be
14	writing, reading, or sending a text message if the person reads, selects, or enters a
15	telephone number or name in a wireless telecommunications device for the purpose
16	of making a telephone call.
17	(2) No person shall operate any motor vehicle upon any public road or
18	highway of this state while using a wireless telecommunications device to access,
9	read, or post to a social networking site.

8	C.(1) The first violation of the provisions of this Section shall be punishable
9	by a fine of not more than five hundred dollars.
10	(2) Each subsequent violation shall be punishable by a fine of not more than
11	one thousand dollars.
12	(3) If the person is involved in a crash at the time of violation, then the fine
13	shall be equal to double the amount of the standard fine imposed in this Subsection
14	and the law enforcement officer investigating the crash shall indicate on the written
15	accident form that the person was using a wireless telecommunications device at the
16	time of the crash.
17	(4) Any violation of this Section shall constitute a moving violation.
18	§300.8.§300.5. Use of wireless telecommunications devices in school zones
19	prohibited; exceptions
20	A. As used in this Section, the following terms shall have the meanings
21	ascribed to them in this Section, unless the context clearly indicates a different
22	meaning:
23	(1) "Access, read, or post to a social networking site" means using a wireless
24	telecommunications device to access, read, or post on such device to any web-based
25	service that allows individuals to construct a profile within a bounded system,
26	articulate a list of other users with whom they share a connection, and communicate
27	with other members of the site.

20	B.(1) Except as provided in Subsection C of this Section, no person shall
21	operate any wireless telecommunications device while operating a motor vehicle
22	upon any public road or highway during the posted hours within a school zone on
23	such public road or highway.
24	(2) Operating a wireless telecommunications device shall include:
25	(1) (a) Engaging in a call.
26	(2) (b) Writing, sending, or reading a text-based communication.
27	(3) (c) Accessing, reading, or posting to a social networking site.
28	(d) Using any other application or feature of such a device by making
29	manual entries of letters, numbers, symbols, or any combination thereof.

(2) "Engage in a call" means talking or listening during a voice transmission

2	of the following persons while they are performing their official duties:
3	(a) A law enforcement officer.

21	(5) Uses a wireless telecommunications device in an official capacity as an
22	operator of an authorized emergency vehicle.
23	D.(1) Any violation of this Section shall constitute a moving violation.
24	(2)(a) The first violation of the provisions of this Section shall be punishable
25	by a fine of not more than five hundred dollars.
26	(b) Each subsequent violation shall be punishable by a fine of not more than
27	one thousand dollars and a suspension of driver's license for a sixty-day period.
28	(c) If a person is involved in a collision at the time of the violation,
29	regardless of whether the violation is the legal cause of the collision, then the fine

shall be equal to double the amount of the standard fine imposed in this Subsection

written accident report that the person was using a wireless telecommunications

(3) It Use of a wireless telecommunications device for any of the purposes
provided for in Subsection C of this Section shall be an affirmative defense against
an alleged to a violation of this Section and the alleged violator for the person may
to produce documentary or other evidence in support of this defense that the wireless
telecommunications device that is the basis of the alleged violation was used for
emergency purposes as provided in Subsection C of this Section.
E. The provisions of this Section shall only apply within a school zone upon
a public road or highway during posted hours when signs are located in a visible
manner in each direction that indicate the use of a hand-held wireless
communications device is prohibited while operating a motor vehicle.
Section 2. R.S. 32:300.6, 300.7, and 300.8 are hereby repealed in their entirety.

Abstract: Modifies provisions applicable to the use of a wireless communications device while operating a motor vehicle.

Present law prohibits the use of wireless telecommunications devices in school zones.

<u>Proposed law</u> extends the prohibition to include general usage of wireless telecommunications devices while driving.

<u>Present law</u> defines the term "engage in a call" as talking or listening on a wireless telecommunications device.

<u>Proposed law</u> modifies <u>present law</u> by defining the term "engage in a call" as talking or listening during a voice transmission on a wireless telecommunications device or manually entering names or phone numbers to initiate a call.

<u>Present law</u> specifies that operating a wireless telecommunications device includes engaging in a call; writing, sending, or reading a text-based communication; and accessing, reading, or posting to a social networking site.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> adds to <u>present law</u> the use of any other application or feature of such a device by making manual entries of letters, numbers, symbols, or any combination thereof.

<u>Proposed law</u> provides exceptions for operating a wireless telecommunication device while operating a motor vehicle upon any public road or highway for law enforcement officers, firefighters, and operators of authorized emergency vehicles.

<u>Present law</u> provides exceptions for operating a wireless telecommunication device while operating a motor vehicle upon any public road or highway for a person who uses a wireless telecommunication device: to report a traffic collision, medical emergency, or serious road hazard; to report a situation in which the person believes his personal safety is in jeopardy; to report or avert the perpetration or potential perpetration of a criminal act against the driver or another person; or while the motor vehicle is parked.

<u>Proposed law</u> modifies the exception in <u>present law</u> by specifying that it applies to a person using a wireless telecommunications device: to report other emergencies; to report a situation in which the person believes that an individual is in jeopardy of serious injury or death; to relay information between a transit or for-hire operator, including a transportation network company driver, and that operator's dispatcher, in which the device is affixed to the vehicle; and to navigate using a global positioning system. <u>Proposed law</u> removes the exceptions for a person using a wireless telecommunications device to: report a situation in which the person believes their personal safety is in jeopardy; or report or avert the perpetration or potential perpetration of a criminal act against the driver or another person.

<u>Present law</u> requires that a person involved in a collision at the time of the violation of <u>present law</u> be fined equal to double the amount of the standard fine imposed in <u>present law</u>.

<u>Proposed law</u> clarifies that a person involved in a collision at the time of the violation of <u>present law</u> must be fined equal the amount of the standard fine imposed in <u>present law</u> regardless of whether the violation is the legal cause of the collision.

<u>Present law</u> establishes an affirmative defense against an alleged violation of <u>present law</u> by allowing the person to produce documentary or other evidence that the wireless telecommunications device that is the basis of the alleged violation was used for emergency purposes as provided for in <u>present law</u>.

<u>Proposed law</u> modifies <u>present law</u> by specifying that use of a wireless telecommunications device for any of the exceptions provided for in <u>present law</u> is an affirmative defense to a violation of <u>present law</u> in support of which the alleged violator may produce documentary or other evidence.

<u>Present law</u> specifies that the provisions of <u>present law</u> only apply within a school zone upon a public road or highway during posted hours when signs are located in a visible manner in each direction that indicate the use of hand held wireless communications device is prohibited while operating a motor vehicle.

Proposed law repeals present law.
