SUPPLEMENTAL PAY OR +\$1,836,000 GF EX See Note Authorizes supplemental pay for certain university or college police officers

Present law provides for supplemental pay of \$500 per month for any state or local police officer who serves the welfare of the general public by providing police services and who has completed and passed a council-certified training program and has completed one year of service.

Proposed law retains present law and adds full time police officers of public, four-year college or university campuses to the list of police officers eligible to receive supplemental pay of \$500 per month. To be eligible, police officers must complete one year of service and be P.O.S.T.-certified.

EXPENDITURE EXPLANATION

Proposed law will increase annual SGF expenditures in Other Requirements Schedule 20-966 by approximately \$1.84 M to provide supplemental payments of \$500 monthly to law enforcement officers at public, four-year postsecondary institutions (see *NOTE* below). As of March 2019, there are 306 full-time police officers at public, four-year institutions that would be eligible to receive this monthly supplemental pay.

NOTE: This estimate includes 13 officers at LSU Health Sciences Centers - New Orleans (LSUHSC-NO) at an annual cost of \$78,000 and 30 officers at LSU Health Sciences Centers - Shreveport (LSUHSC-S) at an annual cost of \$180,000, since both have a Carnegie Classification as a "Special Focus Four-Year" institution. <u>HSCNO is currently in the process of hiring 18</u> additional police officers (to a total of 31 from 13) that are not included in this estimate. To the extent these positions are added, the supplemental pay for these 18 positions equates to an additional \$108,000 SGF (18 x \$500 x 12 months) in annual supplemental payments and the baseline SGF increase noted in the EXPENDITURES box above would change to \$1,944,000 in each of Fiscal Years 21 through 24.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
