HEALTH CARE/FACILITIES OR +\$1,800 SG RV See Note Provides relative to the licensing of free standing birth centers

<u>Proposed law</u> authorizes the Louisiana Department of Health to promulgate rules for the licensing of free standing birth centers. <u>Proposed law</u> defines a free standing birth center, and provides for licensing fees (initial and renewal) of free standing birth centers.

Proposed law requires LDH to perform an onsite survey and inspection of the free standing birth center facility following the receipt of a completed initial licensing application and the licensing fee.

Proposed law provides for penalties for any facility or center operating without a license.

## **EXPENDITURE EXPLANATION**

The Louisiana Department of Health indicates there are three (3) existing free standing birth centers. Additional administrative functions associated with processing license applications is anticipated to be covered with with existing staff. Operational expenses associated with travel to perform on-site facility surveys and inspections is anticipated to be nominal, and anticipated to be covered with revenues generated through initial and renewal licensing of such facilities.

## **REVENUE EXPLANATION**

Based on the current number of free standing birth centers (FSBC's) in the state and a \$600 licensing fee, the department projects generating and additional \$1,800 annually through initial licensing and licensing renewal fees.

Note: Proposed law provides for financial penalties on FSBC's if operating without a license. Any center or facility operating without a license shall be charged with a misdemeanor, and upon conviction, subject to fines of not less than \$250 and \$1,000 each day in violation.
