PUBLIC BUILDINGS/GROUNDS. Authorizes the state of Louisiana to sell or transfer certain state property. (8/1/19)

AN ACT
To enact R.S. 40:16.4, relative to the transfer or sale of certain state property; to provide for
the property descriptions; to provide for reservation of mineral rights; to provide for
terms and conditions; to provide for dedication of funds; to provide for the creation
of the Louisiana Department of Health's Facility Support Fund Number 2; to provide
for the transfer, use, and investment of monies in the fund; and to provide for related
matters.
Be it enacted by the Legislature of Louisiana:
Section 1. The commissioner of administration and the secretary of the
Louisiana Department of Health, notwithstanding any other provision of law to the
<u>contrary, are hereby authorized and empowered to convey, transfer, assign, lease, or</u>
deliver any interest, excluding mineral rights, the state may have to all or any portion
of the following described parcels of property pursuant to R.S. 41:131 et seq.:
A. That certain tract or parcel of land situated in Rapides Parish,
Louisiana, containing 204.80 acres, more or less fronting on Red River
a short distance above Pineville, and being the upper half of Section 17.
Township Four (4) North Range One (1) West, and being bounded in

5	proceeds necessary to offset its appraisal, survey, and other closing costs occasioned by
6	the transaction described in Section 1. The remaining proceeds shall be deposited into
7	the Louisiana Department of Health Facility Support Fund Number 2 and be dedicated
8	to the planning, design, permits, improvements, repairs, equipment, restoration,
9	renovation, or construction of the Central Louisiana State Hospital. The proceeds from
10	the transactions described in Sections 2 and 3 shall be deposited into the state treasury
11	in accordance with R.S. 39:13 and R.S. 41:131 et seq.
12	Section 9. R.S. 40:16.4 is hereby enacted to read as follows:
13	<u>§16.4. Louisiana Department of Health's Facility Support Fund Number 2</u>
14	A. There is hereby created, as a special fund in the state treasury, the
15	Louisiana Department of Health's Facility Support Fund Number 2, hereinafter
16	referred to as the "fund".
17	B.(1) Notwithstanding any other provision of law to the contrary, after
18	compliance with the requirements of Article VII, Section 9(B) of the
19	Constitution of Louisiana, relative to the Bond Security and Redemption Fund,
20	and after a sufficient amount is allocated from that fund to pay all of the
21	obligations secured by the full faith and credit of the state which become due
22	and payable within any fiscal year, the treasurer shall pay an amount into the
23	fund equal to the amount collected by the state from the proceeds of the sale or
24	transfer of certain lands as provided in Section 1 of the Act which originated as
25	Senate Bill No. 149 of the 2019 Regular Session of the Legislature, less the
26	amount of the sale proceeds to be deducted by the state land office to offset its
27	appraisal, survey, and other closing costs occasioned by the transactions.
28	(2) Monies appropriated from the fund shall be used solely as provided
29	in Subsection C of this Section and only in the amounts appropriated by the

1	legislature. All unexpended and unencumbered monies in the fund at the end
2	of the fiscal year shall remain in the fund. The monies in the fund shall be
3	invested by the state treasurer in the same manner as monies in the state
4	general fund, and interest earned on the investment of these monies shall be
5	credited to the fund following compliance with the requirements of Article VII,
6	Section 9(B) of the Constitution of Louisiana, relative to the Bond Security and
7	Redemption Fund.
8	C. Subject to annual appropriation by the legislature, the monies in the
9	fund shall be used solely for the planning, design, permits, improvements,
10	repairs, equipment, restoration, renovation, or construction of the Central
11	Louisiana State Hospital.

Present law provides a procedure for the sale of public lands.

Authorizes commissioner of administration and LDH to transfer certain property related to the Central Louisiana Hospital in Rapides Parish pursuant to <u>present law</u>.

Authorizes the commissioner of administration and the secretary of DOTD to transfer certain property to the Louisiana Department of Health.

Authorizes the commissioner of administration and the secretary of DOTD to transfer certain property in Rapides Parish to the town of Boyce.

<u>Proposed law</u> creates the Louisiana Department of Health's Facility Support Fund Number 2 and provides for the transfer, use, and investment of monies in the fund.

Requires that after subtracting costs incurred by the division of administration related to the sale of the Central Louisiana State Hospital properties, the proceeds of any sale be paid into the LDH Facility Support Fund Number 2 and dedicated to the planning, design, permits, improvements, repairs, equipment, restoration, renovation, or construction of the Central Louisiana State Hospital.

Effective August 1, 2019.

Summary of Amendments Adopted by Senate

Committee Amendments Proposed by Senate Committee on Finance to the original bill

- 1. Deletes authorization for the commissioner of administration and the secretary of DCFS to transfer certain property in Jackson Parish to the Greater North Louisiana Community Development Corporation.
- 2. Adds authorization for the commissioner of administration and the secretary of DOTD to transfer certain property to the Louisiana Department of Health.
- 3. Creates the Louisiana Department of Health's Facility Support Fund Number 2, and provides for the transfer, use, and investment of monies in the fund.
- 4. Provides that monies in the fund may also be used for planning, design, permits, improvements, repairs and equipment.
- 5. Clarifies that the proceeds from the transactions described in Sections 2 and 3 shall be deposited in the state treasury in accordance with <u>present law</u>.
