Abstract: Provides alternative means of verifying that a person is twenty-one years or older for the purpose of selling or serving alcoholic beverages.

<u>Present law</u> provides a list of certain types of identification to be used for verifying the age of persons when selling or serving alcoholic beverages.

<u>Proposed law</u> retains the <u>present law</u> list of certain types of identification and provides an alternative method (real-time verification) that may be used to verify the age of persons when selling or serving alcoholic beverages. Requires the commissioner of ATC to authorize the real-time age verification system.
