2 On page 1, line 2, after "R.S. 47:32(A)," and before "and (10)," delete "79, 93(B), 241,
3 293(3)" and insert "293(3), (9)(a)(iv),"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "300.7(A)" delete the comma "," and delete the remainder of the line
6 in its entirety and insert "and to repeal R.S. 47:293(4)"

7 AMENDMENT NO. 3

8 On page 1, line 4, after "296.1(B)(3)(c)," and before "and" insert "297(A),"

9 AMENDMENT NO. 4

10 On page 1, line 14, after "R.S. 47:32(A)," and before "and (10)," delete "79, 93(B), 241,
11 293(3)" and insert "293(3), (9)(a)(iv),"

12 AMENDMENT NO. 5

13 On page 1, line 15, after "reenacted" delete the remainder of the line in its entirety and at the

15 AMENDMENT NO. 6

16 On page 2, delete lines 10 through 29 in their entirety, delete pages 3 through 8 in their
17 entirety and on page 9, delete lines 1 through 5 in their entirety

18 AMENDMENT NO. 7

19 On page 9, between lines 24 and 25, insert the following:

20 "9)(a) "Tax table income", for resident individuals, means adjusted gross
21 income plus interest on obligations of a state or political subdivision thereof, other
22 than Louisiana and its municipalities, title to which obligations vested with the
23 resident individual on or subsequent to January 1, 1980, and less:
