1 §307. Civil penalty

2	Any fantasy sports contest operator who violates any procedure implemented
3	pursuant to this Chapter shall be liable for a civil penalty of not more than one
4	thousand dollars for each violation, not to exceed fifty thousand dollars for violations
5	arising out of the same transaction or occurrence, which shall accrue to the state and
6	may be recovered in a civil action brought by the board."
