14 "rendering provider unless any of the following conditions are met:"**15** AMENDMENT NO. 6**16** On page 2, delete lines 3 through 16 in their entirety and insert in lieu thereof the following:**17** "(a) The medical necessity of the services is documented for a Medicaid
18 recipient receiving more than twelve hours of CPST and PSR services per day per
19 rendering provider.**20** (b) The services are billed for a group setting. However, the total hours
21 worked by an individual rendering provider shall not exceed twelve reimbursable
22 hours per calendar day.**23** (c) The services are billed for crisis intervention."**24** AMENDMENT NO. 7**25** On page 2, line 17, delete "(c)" and insert in lieu thereof "(3)(a)" and at the end of the line
26 delete "this Paragraph" and insert in lieu thereof "Paragraph (2) of this Subsection"**27** AMENDMENT NO. 8**28** On page 2, line 18, delete "all" and insert in lieu thereof "only"**29** AMENDMENT NO. 9**30** On page 2, line 20, after "within a" delete the remainder of the line and insert in lieu thereof
31 "calendar day."

2 On page 2, delete lines 21 through 24 in their entirety and insert in lieu thereof the following:

3 "(b) The twelve-hour limitation provided in Paragraph (2) of this Subsection
4 shall not apply per individual behavioral health services provider agency.

5 (4) The provisions of this Subsection shall not apply to evidence-based
6 practices including, without limitation, the practices known as assertive community
7 treatment, multisystemic therapy, functional family therapy, and homebuilders."
