HEALTH SERVICES OR INCREASE GF EX See Note Page 1 of 1

Requires the provision of certain information to patients or parents of patients prior to administration of an immunization or a vaccine

Proposed law requires certain information be given to patients or parents/guardians of minor patients when vaccines or immunizations are administered by physicians, physicians assistants, registered nurses, practical nurses, or pharmacists. Proposed law requires providers to disclose the following vaccine information: the diseases or conditions that the vaccines or immunizations are intended to prevent/treat; the vaccine or immunization effectiveness; any contraindications; possible side effects; ingredients of the vaccines or immunizations; and instructions for reporting to the federally managed Vaccine Adverse Events Reporting System. Proposed law requires all providers licensed by the LA Dept. of Health where vaccines or immunizations are administered to disclose the aforementioned information in written form.

**EXPENDITURE EXPLANATION**

Proposed law may increase SGF expenditures for the LA Dept. of Health, Office of Public Health (OPH) by an indeterminable amount in FY 20 and subsequent fiscal years. OPH reports that it anticipates being required to print out vaccine information required to be provided to patients and/or the parent or guardian of minor patients for providers who administer vaccines under OPH programs. Based upon an estimate provided by the Office of State Printing, OPH reports that its anticipated costs associated with proposed law total an estimated \$2.6 M SGF in FY 20 and subsequent fiscal years. It is unclear if providers or OPH would be required to assume the costs associated with printing the additional vaccine information associated with administering vaccines under OPH programs. However, to the OPH's reported costs may potentially be mitigated to the extent their staff can compile the information required pursuant to the proposed legislation and make it available to providers online in a format that can be printed on-demand when vaccines are administered. The Legislative Fiscal Office is seeking additional information regarding potential costs associated with the proposed legislation from OPH.

In addition to the aforementioned impacts, the Legislative Fiscal Office is currently seeking information regarding impacts of proposed law on the LA State Board of Medical Examiners, the LA State Board of Nursing, and the LA State Board of Practical Nurse Examiners.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
