1 AMENDMENT NO. 1

2 On page 1, line 3, after "47:851(C)(2)" and before "and to repeal" insert a comma "," and
3 insert "to enact R.S. 14:91.6(D) and 91.8(K) and R.S. 26:910.1(C) and 911(D),"

4 AMENDMENT NO. 2

5 On page 1, line 5, after "vapor products;" and before "to raise" insert "to provide for an
6 exception;"

7 AMENDMENT NO. 3

8 On page 1, at the beginning of line 14, after "reenacted" and before "to read" insert "and R.S.
9 14:91.6(D) and 91.8(K) are hereby enacted"

10 AMENDMENT NO. 4

11 On page 1, at the beginning of line 18, after "A." and before "person" delete "No" and insert
12 "Except as provided in Subsection D of this Section, no"

13 AMENDMENT NO. 5

14 On page 1, after line 21, insert the following:

15 "D. Notwithstanding the provisions of this Section or any other provision of
16 law to the contrary, nothing within this Section shall be construed to apply if a
17 product or combination of products are distributed or are caused to be distributed to
18 a person who has reached the age of eighteen before August 1, 2019.

20 AMENDMENT NO. 6

21 On page 2, at the end of line 15, after "AGE" delete the remainder of the line in its entirety
22 and insert the following:

23 "18 21. PERSONS WHO HAVE REACHED THE AGE OF 18 OR OLDER ON OR
24 BEFORE AUGUST 1, 2019, ARE NOT SUBJECT TO THIS PROHIBITION".

26 AMENDMENT NO. 7

27 On page 2, line 25, after "AGE" delete the remainder of the line in its entirety and insert the
28 following:

29 "18 21. PERSONS WHO HAVE REACHED THE AGE OF 18 OR OLDER ON OR
30 BEFORE AUGUST 1, 2019, ARE NOT SUBJECT TO THIS PROHIBITION". The
31 sign shall also"

1 AMENDMENT NO. 8

2 On page 3, between lines 3 and 4, insert the following:

3 "K. Notwithstanding the provisions this Section or any other provision of
4 law to the contrary, nothing within this Section shall be construed to apply if a
5 product or combination of products are sold or distributed by a person who has
6 reached the age of eighteen or older on or before August 1, 2019."

7 AMENDMENT NO. 9

8 On page 3, line 5, after "reenacted" and before "to read" insert "and R.S. 26:910(C) and
9 911(D) are hereby enacted"

10 AMENDMENT NO. 10

11 On page 3, delete line 13 in its entirety and insert the following:

12 "over the age of eighteen or and under the age of twenty-one may shall be enlisted
13 by employees of the"

14 AMENDMENT NO. 11

15 On page 4, at the beginning of line 7, insert "A."

16 AMENDMENT NO. 12

17 On page 4, between lines 18 and 19, insert the following:

18 "B. Notwithstanding the provisions this Section or any other provision of law
19 to the contrary, nothing within this Section shall be construed to apply if a product
20 or combination of products are purchased or delivered from a vending machine to
21 a person who has reached the age of eighteen or older on or before August 1, 2019."

22 AMENDMENT NO. 13

23 On page 4, between lines 25 and 26, insert the following:

24 "C. Notwithstanding the provisions this Section or any other provision of law
25 to the contrary, nothing within this Section shall be construed to apply if a product
26 or combination of products are purchased or delivered from a self-service display by
27 a person who has reached the age of eighteen or older on or before August 1, 2019."

28 AMENDMENT NO. 14

29 On page 5, between lines 12 and 13, insert the following:

30 "D. Notwithstanding the provisions this Section or any other provision of law
31 to the contrary, nothing within this Section shall be construed to apply if a product
32 or combination of products are sold or served to a person who has reached the age
33 of eighteen or older on or before August 1, 2019.

37 On page 5, at the beginning of line 14, insert "A."

1 AMENDMENT NO. 16

2 On page 6, between lines 9 and10, insert the following:

3 "B. Notwithstanding the provisions this Section or any other provision of law
4 to the contrary, nothing within this Section shall be construed to apply if a product
5 or combination of products are sold to a person who has reached the age of eighteen
6 or older on or before August 1, 2019."

7 AMENDMENT NO. 17

8 On page 6, line 22, after "AGE" delete the remainder of the line in its entirety and insert the
9 following:

10 "~~18.~~ 21. PERSONS WHO HAVE REACHED THE AGE OF 18 OR OLDER ON
11 OR BEFORE AUGUST 1, 2019, ARE NOT SUBJECT TO THIS PROHIBITION"."
