COMMENDATIONS: Commends Bradley Spicer for 55 years of public service and congratulates him upon his retirement

1	A CONCURRENT RESOLUTION
2	To commend Bradley Spicer for fifty-five years of exemplary public service and to
3	congratulate him upon his retirement from the Louisiana Department of Agriculture
4	and Forestry.
5	WHEREAS, the Legislature of Louisiana commends Mr. Spicer for the exceptional
6	public service he has provided to the state of Louisiana over his decades of dedicated
7	conservation work; and
8	WHEREAS, Mr. Spicer is a native of Oak Hall Station, Pennsylvania, and a graduate
9	of State College High; and
10	WHEREAS, upon graduation Mr. Spicer served in the United States Air Force as an
11	in-flight refueling specialist for the Strategic Air Command during the Cold War; and
12	WHEREAS, after being honorably discharged from active duty in 1960, Mr. Spicer
13	continued to serve in the Air Force Reserves to ensure he would be available for active duty
14	should a national emergency occur; and
15	WHEREAS, Mr. Spicer received his bachelor of science in agronomy in 1965 from
16	the University of Southwestern Louisiana; and
17	WHEREAS, he later received his master in agronomy with a minor in
18	geomorphology in 1969 from Louisiana State University; and
19	WHEREAS, Mr. Spicer is a licensed professional geoscientist and during his career
20	he has authored and coauthored numerous technical and scientific articles and reports; and

1 WHEREAS, Mr. Spicer began his career in conservation in 1965 working as a soil 2 scientist for the United States Department of Agriculture, Soil Conservation Service (SCS) 3 in Baton Rouge; and 4 WHEREAS, he spent twenty years with the SCS, during which time he was placed 5 on special assignments assisting state agencies, including the office of the governor, the 6 Department of Natural Resources, coastal management division, and the Department of 7 Agriculture and Forestry, in natural resource conservation; and 8 WHEREAS, Mr. Spicer changed the way Louisiana treats soil and water 9 conservation by developing comprehensive and coordinated conservation systems; and 10 WHEREAS, he was the driving force in moving soil and water conservation from 11 the Department of Transportation and Development to the Department of Agriculture and 12 Forestry and creating the office of soil and water conservation; and 13 WHEREAS, he has continued to steer conservation efforts in our state and has 14 overseen the development of conservation programs from their infancy through decades of 15 maturation; and 16 WHEREAS, Mr. Spicer has served as the assistant commissioner for the Louisiana 17 Department of Agriculture and Forestry, office of soil and water conservation, and executive 18 director of the State Soil and Water Conservation Commission since January 1986; and 19 WHEREAS, Mr. Spicer's passion and commitment to conservation have made him 20 an invaluable leader in natural resource conservation efforts, both in Louisiana and 21 nationwide, and he has received recognition for his contributions at the state and national 22 levels; and 23 WHEREAS, Mr. Spicer served as the president of National Association of State 24 Conservation Agencies and was awarded the National Association of Conservation Districts' 25 Professional Service Award in 2000; and 26 WHEREAS, Mr. Spicer has overseen numerous committees, task forces, programs, 27 and conservation activities over the years and served as an advisor on former Governor 28 Buddy Roemer's transition team; and 29 WHEREAS, Mr. Spicer has been instrumental in many of Louisiana's major natural 30 resource conservation milestones over the past five decades, including the passage of the

1	State and Local Coastal Resources Management in 1978 and the creation of the Wetlands
2	Conservation and Restoration Authority in 1989, which was the forerunner to the Coasta
3	Protection and Restoration Authority, and the Ground Water Resources Commission in
4	2001; and
5	WHEREAS, while serving as state ambassador to the United States National Guard
6	Mr. Spicer, among other activities, traveled to Honduras in 1998 to review the National
7	Guard's recovery efforts following Hurricane Mitch; and
8	WHEREAS, Mr. Spicer again utilized his knowledge and expertise in the aftermath
9	of Hurricane Katrina, when he worked long hours at FEMA headquarters coordinating debris
10	recovery efforts with the United States Army Corps of Engineers and FEMA; and
11	WHEREAS, Mr. Spicer is driven by his passion for conservation and desire to
12	preserve the beautiful state of Louisiana for his children and grandchildren; and
13	WHEREAS, Mr. Spicer's retirement is a tremendous loss for the Department of
14	Agriculture and Forestry and our state, but his legacy will endure for future generations who
15	benefit from his conservation work.
16	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
17	commend Bradley Spicer for his fifty-five years of dedicated public service and congratulate
18	him upon his retirement.

20	Bradley Spicer.
