1	AN ACT
2	To amend and reenact R.S. 16:10(A) and 16:11(A)(1), relative to annual salary of district
3	attorneys payable by state; relative to annual salary of assistant district attorneys by
4	state; to provide for an increase in annual salary of district attorneys and assistant
5	district attorneys; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 16:10(A) and 11(A)(1) are hereby amended and reenacted to read
8	as follows:
9	§10. Annual salary of district attorneys payable by state
10	A.(1) The annual salary of the several district attorneys throughout the state
11	of Louisiana is hereby fixed at fifty thousand dollars payable monthly by the state
12	treasurer upon the warrant of the district attorney.
13	(2) Effective July 1, 2020, the annual salary of the several district attorneys
14	throughout the state of Louisiana is hereby fixed at fifty-two thousand five hundred
15	dollars payable monthly by the state treasurer upon the warrant of the district
16	attorney. Effective July 1, 2021, the annual salary of the several district attorneys
17	throughout the state of Louisiana is hereby fixed at fifty-five thousand dollars
18	payable monthly by the state treasurer upon the warrant of the district attorney.

§11. Annual salary of assistant district attorneys payable by state

2 A.(1) Except as provided in Paragraph (2) of this Subsection, effective July 3 1, 2006, the annual salary of each of the several assistant district attorneys 4 throughout the state of Louisiana, including the parish of Orleans, is hereby fixed at 5 thirty-five thousand dollars payable monthly by the state treasurer upon the warrant 6 of each of the assistant district attorneys. Effective July 1, 2007, the annual salary 7 of each of the several assistant district attorneys, throughout the state of Louisiana, 8 including the parish of Orleans, is hereby fixed at forty thousand dollars payable 9 monthly by the state treasurer upon the warrant of each of the assistant district 10 attorneys. Effective July 1, 2008, the annual salary of each of the several assistant 11 district attorneys, throughout the state of Louisiana, including the parish of Orleans, 12 is hereby fixed at forty-five thousand dollars payable monthly by the state treasurer 13 upon the warrant of each of the assistant district attorneys. Effective July 1, 2020, 14 the annual salary of each of the several assistant district attorneys throughout the 15 state of Louisiana, including the parish of Orleans, is hereby fixed at forty-seven 16 thousand five hundred dollars payable monthly by the state treasurer upon the 17 warrant of each of the assistant district attorneys. Effective July 1, 2021, the annual 18 salary of each of the several assistant district attorneys throughout the state of 19 Louisiana, including the parish of Orleans, is hereby fixed at fifty thousand dollars 20 payable monthly by the state treasurer upon the warrant of each of the assistant 21 district attorneys. Any increase in salary shall be subject to an appropriation for that 22 purpose.

Abstract: Increases the salary of district attorneys <u>from</u> \$50,000 to \$52,500 beginning July 1, 2020, and to \$55,000 beginning July 1, 2021. Further, increases the salary of assistant district attorneys <u>from</u> \$45,000 to \$47,500 beginning July 1, 2020, and to \$50,000 beginning July 1, 2021.

<u>Present law</u> provides that district attorneys statewide are to receive an annual salary of \$50,000 payable monthly.

<u>Present law</u> provides that, effective July 1, 2008, assistant district attorneys statewide are to receive an annual salary of \$45,000 payable monthly.

<u>Proposed law</u> increases the salary of the district attorney to \$52,500 beginning July 1, 2020, and to \$55,000 beginning July 1, 2021.

<u>Proposed law</u> increases the salary of the assistant district attorneys to \$47,500 beginning July 1, 2020, and to \$50,000 beginning July 1, 2021.

Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on Judiciary</u> to the <u>original</u> bill:
- 1. Increase the district attorney's salary to \$52,500 beginning July 1, 2020, and to \$55,000 beginning July 1, 2022.
- 2. Increase the assistant district attorney's salary to \$47,500 beginning July 1, 2020, and to \$50,000 beginning July 1, 2021.

The Committee Amendments Proposed by <u>House Committee on Appropriations</u> to the <u>engrossed</u> bill:

1. Change the effective date to increase the district attorney's salary to \$55,000 <u>from</u> July 1, 2022, to July 1, 2021.
