CONDOLENCES: Expresses condolences on the death of Donna Klein

2	To express the condolences of the House of Representatives upon the death of Donna G.
3	Klein.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	Louisiana House of Representatives have learned of the death of one of Louisiana's brightest
6	lights, Donna Klein, on May 14, 2019, at the age of seventy-two; and
7	WHEREAS, Donna Klein was born on January 30, 1947, in Philadelphia, to Frank
8	H. and Margaret T. Guinn; and
9	WHEREAS, when Donna was growing up, her father was in the Army and her family
10	moved from state to state, living in Texas, New Jersey, Virginia, and finally, Florida; she
11	earned an associate degree in nursing at Manatee Junior College (now known as Manatee
12	Technical College) in Bradenton, Florida, and thereafter moved to New Orleans to work in
13	Ochsner Foundation Hospital's intensive care unit, eventually becoming acting supervisor;
14	and
15	WHEREAS, she met and married Russell Klein and walked away from her nursing
16	career; a year later, she signed up for political science classes at Loyola University, and at
17	the age of twenty-seven, with two children and five years of nursing experience, Donna
18	decided to pursue a law degree; and
19	WHEREAS, armed with a bachelor of arts in political science from Loyola and a
20	juris doctorate from Tulane, she went on to develop an expertise in health care law; Donna
21	was one of the first female healthcare attorneys in the city of New Orleans; in September

1 2018 Donna retired as general counsel for Peoples Health Network, a Medicare Advantage 2 organization with more than seventy-five thousand members; and 3 WHEREAS, prior to joining Peoples Health, Donna was managing partner of 4 McGlinchey Stafford, PLLC, in its New Orleans office, head of the healthcare group, partner 5 in charge of marketing, and a member of its management committee; and 6 WHEREAS, she was active in the New Orleans community and was involved in 7 dozens of non-profit pursuits, including serving as a member of the boards of City Year New 8 Orleans, the Dryades YMCA, the Louisiana Philharmonic Orchestra, the New Orleans 9 Center for the Creative Arts, the Louisiana Children's Museum, and the Earnest N. Morial 10 Convention Center; she served on the Board of Regents and was chair of the American Heart 11 Association Metro New Orleans Board of Directors, board member and head of the 12 leadership program of the Metropolitan Area Committee/Committee for a Better New 13 Orleans, and a member of the Bayou District of New Orleans Board of Commissioners; and 14 WHEREAS, Donna was recognized for her service numerous times: in 2008 New 15 Orleans City Business inducted her into the Women of the Year Hall of Fame, an honor 16 bestowed only upon those who have been named Woman of the Year three times or more; 17 in 2003 she was the recipient of the Human Rights Campaign humanitarian award; Donna 18 served on the health care transition teams for former governors Kathleen Blanco, Edwin 19 Edwards, and Mike Foster; and 20 WHEREAS, Donna Klein was a tireless advocate for the New Orleans community 21 at large and made paramount contributions to healthcare in Louisiana; she had a deep 22 appreciation for the arts and enjoyed cooking and hosting people in her and Russell's home; 23 and 24 WHEREAS, Donna G. Klein is survived by her children, Robin Klein and Steven 25 Klein, and his wife Helen; sister, Margaret Scott, and her husband Greg; nieces, Brooke 26 Nichols, and her husband Josh, and Tyler Wright, and her husband Kevin; nephews, Tucker 27 Scott and Casan Scott, and his wife Jannie; brother-in-law, Edward J. Klein, Jr.; devoted 28 dog, Jesse; and countless dear friends; and

- WHEREAS, although the death of Donna Klein has left a tremendous void in the
- 2 healthcare and legal communities that she served so long and so well, her legacy shall live
- 3 forever in the hearts and minds of all the citizens whose lives she touched.
- THEREFORE, BE IT RESOLVED that the House of Representatives of the
- 5 Legislature of Louisiana does hereby express condolences upon the death of Donna G.
- 6 Klein; does hereby recognize and record for posterity the contributions and accomplishments
- 7 of Mrs. Klein, an exemplary citizen, nurse, lawyer, wife, mother, and friend, to the city of
- 8 New Orleans and to our state and nation; and does hereby pay tribute to her for the generous
- 9 and effective way in which she dedicated her intelligence and her energy to justice.

- 11 family of Donna Klein.
