1 AMENDMENT NO. 1

2 Delete Amendment No. 1 proposed by the Senate Committee on Revenue and Fiscal Affairs  
3 and adopted by the Senate on May 14, 2019.

4 AMENDMENT NO. 2

5 On page 1, line 2, delete "and R.S. 40:1046(H)(8)(a)" and insert:

6 " , R.S. 40:1046(H)(8)(a), R.S. 40:1046(H)(8)(a) as enacted by Section 1 of  
7 Act No. 567 and Section 2 of Act No. 96 both of the 2016 Regular Session  
8 of the Legislature of Louisiana, and R.S. 47:287.73(C)(4)"

9 AMENDMENT NO. 3

10 On page 3, between lines 12 and 13, insert:

11 "Section 3. R.S. 40:1046(H)(8)(a) as enacted by Section 1 of Act No. 567 and  
12 Section 2 of Act No. 96, both of the 2016 Regular Session of the Legislature of Louisiana,  
13 is hereby amended and reenacted to read as follows:

14 "§1046. Prescription of marijuana for therapeutic use; rules and regulations;  
15 Louisiana Board of Pharmacy and the adoption of rules and  
16 regulations relating to the dispensing of prescribed marijuana  
17 for therapeutic use; the Department of Agriculture and  
18 Forestry and the licensure of a production facility

22 (8)(a) The department shall perform the following:

23 (i) Establish and collect an annual license fee of one hundred  
24 thousand dollars and an annual permit fee of one hundred dollars for  
25 administrative and inspection costs.

26 (ii) Collect a nonrefundable application fee of ten thousand dollars.

27 (iii) ~~Receive an amount not to exceed seven percent of the gross sales.~~

28 Assess a fee of seven percent of the gross sales of therapeutic marijuana that  
29 shall be collected by the Department of Revenue and shall be subject to the  
30 provisions of Chapter 18 of Subtitle II of Title 47 of the Louisiana Revised  
31 Statutes of 1950 as amended. Notwithstanding the provisions of  
32 Subparagraph (b) of this Paragraph, the department shall transfer monthly to  
33 the state treasury for deposit into the Community and Family Support System  
34 Fund, as established in R.S. 28:826, the amount of revenues collected in  
35 accordance with this Item. An amount shall be allocated to the department,  
36 pursuant to legislative appropriation, for regulatory, administrative,  
37 investigative, enforcement, legal, and other such expenses as may be  
38 necessary to carry out the provisions of this Chapter and for activities  
39 associated with the enforcement of law and regulations governing the  
40 therapeutic marijuana program.
