4	System of Louisiana; to provide for membership of employees of certain public
5	trusts; and to provide for related matters.

9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 11:1903(A)(introductory paragraph) is hereby amended and
11	reenacted and R.S. 11:1902(12)(e) is hereby enacted to read as follows:
12	§1902. Definitions
13	As used in this Chapter, the following words and phrases shall have the
14	following meanings, unless a different meaning is plainly required by context:

18	(e) "Employee" shall also mean a person employed by a public trust that
19	meets all of the following conditions:
20	(i) The trust was created pursuant to R.S. 9:2341 et seq.
21	(ii) The trust exists for the sole benefit of a parish, without regard to the
22	source of funds for such trust.

6	A. Any taxing district of a parish that qualifies as an employer pursuant to
7	R.S. 11:1902(13); or any branch or section of a parish that qualifies as an employer
8	pursuant to R.S. 11:1902(13); including a hospital district, water district, library,
9	district indigent defender program in this state, or soil and water conservation district
10	in this state; and any public corporation created pursuant to R.S. 9:2341 et seq.
11	whose sole beneficiary is a parish in the state is hereby authorized to may submit for
12	approval by the board of trustees a plan for extending the benefits of this Chapter to
13	employees of such district instrumentality. Each such plan or any amendment
14	thereof shall be approved by the board of trustees if it finds that such plan, or such
15	plan as amended, is in conformity with such requirements as are provided in
16	regulations of the board of trustees, except that no such plan shall be approved
