<u>Proposed law</u> may result in an increase in SGF expenditures for OJJ to establish arts-based programming in its juvenile institutions, facilities, and programs. OJJ reports the cost to establish this program annually is \$527,364 for 4 arts instructors, 4 JJS positions and supply expenses at each facility. <u>Proposed law</u> does not require the establishment of this program, it is permissive.
