3	the Jefferson Place/Bocage Crime Prevention and Improvement District; to provide

5	of the district; to provide relative to the levy of a parcel fee; and to provide for

10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 33:9097.12(B), (D)(2), (E)(7), and (F)(3)(c) and (4) are hereby
12	amended and reenacted to read as follows:
13	§9097.12. Jefferson Place/Bocage Crime Prevention and Improvement District

15	B. Boundaries. (1) The boundaries of the district shall be the areas as
16	established in the official subdivision plat filed with the clerk of court of East Baton
17	Rouge Parish for the subdivisions of Bocage, Bocage Estates, Filings 1 through 5 of
18	Jefferson Place, and The Cloisters.
19	(2) Notwithstanding the provisions of Paragraph (1) of this Subsection, the
20	boundaries of the district shall also include the area comprised of Lots 39, 40, 41,
21	42A, 43, and 44 of Bocage Lakes Subdivision, as established on the official
22	subdivision plat filed with the clerk of court of East Baton Rouge Parish, if the

1	inclusion of the area is approved by a majority of the registered voters residing in the
2	area who vote on a proposition at an election held for this purpose in accordance

7	(2) All members of the board shall be residents of and qualified voters within
8	the district.

10	E. Powers and duties. The district, acting through its board, shall have the
11	following powers and duties:

13	(7) To provide for such services and make such expenditures as the board
14	deems proper for the security or beautification of the district, including maintenance
15	and improvement to common areas.

17	F. Parcel fee. The district, through the board, is hereby authorized to impose
18	and collect a parcel fee within the district subject to and in accordance with the
19	provisions of this Subsection.

23	(c) If approved, the fee and the board's authority to increase it shall expire
24	in ten years, but the fee and board authority may be renewed if approved by a
25	majority of the registered voters of the district voting on the proposition at an
26	election as provided in Subparagraph (a) of this Paragraph. Any election to authorize
27	the renewal of the fee shall be held only at the same time as any regularly scheduled
28	election in East Baton Rouge Parish for that purpose in accordance with the
29	Louisiana Election Code. If the fee and board authority is renewed, the term of the
