FUNDS/FUNDING: Provides relative to the dedication of state tax revenues generated in Orleans Parish from slot machine proceeds

AN ACT

2 To amend and reenact R.S. 27:392(C), relative to the dedication of state tax revenues 3 generated in Orleans parish from slot machine proceeds; to provide relative to the 4 deposit of proceeds in certain funds; and to provide for related matters. 5 Be it enacted by the Legislature of Louisiana: 6 Section 1. R.S. 27:392(C) is hereby amended and reenacted to read as follows: 7 §392. Collection and disposition of fees and taxes 8 9 C. Notwithstanding the provisions of Subsection B of this Section to the 10 contrary and after complying with the provisions of Paragraphs (1) through (3) of 11 Subsection B of this Section, the state treasurer shall in each fiscal year deposit and 12 credit the remaining portion of taxable net slot machine proceeds collected from the 13 licensed eligible facility in Orleans Parish as follows: 14 (1) Thirty percent, not to exceed two million dollars, shall be deposited in 15 and credited to the Beautification and Improvement of the New Orleans City Park 16 Fund. Monies in the <u>such</u> fund shall be used solely and exclusively for the purposes as specified in R.S. 27:392(B)(7). 17 18 (2) Twenty percent, not to exceed one million dollars, shall be deposited in 19 and credited to the Greater New Orleans Sports Foundation Fund, hereinafter 20 referred to in this Paragraph as the "fund", which is hereby established in the state

treasury. Monies in the fund shall be withdrawn only pursuant to appropriation by the legislature and shall be used solely and exclusively by the Greater New Orleans Sports Foundation. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the fund shall be credited to the fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund Greater New Orleans Sports Foundation Fund.

(3) Twenty percent, not to exceed one hundred thousand dollars annually, shall be deposited in and credited to the Algiers Economic Development Foundation Fund, hereinafter referred to in this Paragraph as the "fund", which is hereby established in the state treasury. Monies in the fund shall be withdrawn only pursuant to appropriation by the legislature and shall be used solely and exclusively by the Algiers Economic Development Foundation. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the fund shall be credited to the fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund Algiers Economic Development Foundation Fund.

(5) Five percent, not to exceed one hundred thousand dollars annually, shall be deposited in and credited to the Beautification Project for New Orleans Neighborhoods Fund, hereinafter referred to in this Paragraph as the "fund", which is hereby established in the state treasury. Monies in the fund shall be withdrawn only pursuant to appropriation by the legislature and shall be used solely and exclusively by the Beautification Project for New Orleans Neighborhoods, Inc. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the fund shall be credited to the fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund Beautification Project for New Orleans Neighborhoods Fund.

(6) Five percent, not to exceed one hundred thousand dollars annually, shall
be deposited in and credited to the Friends of NORD Fund, hereinafter referred to
in this Paragraph as the "fund", which is hereby established in the state treasury.
Monies in the fund shall be withdrawn only pursuant to appropriation by the
legislature and shall be used solely and exclusively by the Friends of NORD, Inc.
Monies in the fund shall be invested in the same manner as monies in the state
general fund. Interest earned on the investment of monies in the fund shall be
credited to the fund. Unexpended and unencumbered monies in the fund at the end
of the fiscal year shall remain in the fund Friends of NORD Fund.
(7) After making the deposits as required by Paragraphs (1) through (6) of

this Subsection, the state treasurer shall deposit in and credit to the New Orleans Sports Franchise Assistance Fund which is hereby created in the state treasury and which for purposes of this Paragraph shall be known as the "assistance fund". Monies in the assistance fund shall be appropriated and distributed each fiscal year to the Louisiana Stadium and Exposition District for use only to fund contractual obligations of the state to any National Football League or National Basketball Association franchise located in Orleans Parish. Monies in the assistance fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the assistance fund shall be credited to the assistance fund. Unexpended and unencumbered monies in the assistance fund at the end of the fiscal year shall remain in the assistance fund New Orleans Sports Franchise Assistance Fund.
