Provides relative to capital outlay.

The proposed legislation provides that all projects which are funded through a cash mean of finance or received advance funding in a bond sale shall also be included in the annual report to the Joint Legislative Committee on Capital Outlay. The Office of Facility Planning shall continue to include these projects in each annual report until a certificate of completion for the project has been issued. It further provides that the Capital Outlay Act shall include a statement concerning the total outstanding net state tax supported debt as reported by the state treasurer concerning net state tax supported debt.
