HOUSE CONCURRENT RESOLUTION NO. 60

CONGRESS: Memorializes Congress to appropriate additional money for increased seafood testing

A CONCURRENT RESOLUTION

2	To memorialize the United States Congress to take such actions as are necessary to review
3	and consider the appropriation of additional funds for the purpose of performing
4	inspections on foreign seafood processors and farms that import seafood into the
5	United States.
6	WHEREAS, a 2017 study conducted by the U.S. Government Accountability Office
7	found that only a limited number of inspections are performed on foreign seafood processors
8	and farmers; and
9	WHEREAS, foreign seafood, especially those grown in aquaculture facilities, are
10	often treated with large doses of antibiotics and other chemicals to treat diseases and enhance
11	their growth; and
12	WHEREAS, the lack of inspections and testing can lead to unhealthy levels of
13	chemicals and antibiotics in the seafood being consumed by Americans; and
14	WHEREAS, these practices place American commercial seafood producers at a
15	competitive disadvantage with foreign producers who are not held to the same standards; and
16	WHEREAS, the lack of inspection creates a tangible threat to our national security
17	and the health and safety of American citizens; and
18	WHEREAS, the fees collected on imported seafood can be used to fund the hiring
19	of additional inspectors to ensure the safety of imported seafood consumed by Americans.

1 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 2 request that the United States Congress take action to appropriate the necessary funds for the 3 U.S. Department of Agriculture and the U.S. Food and Drug Administration to take 4 immediate measures to significantly increase the level of seafood inspection at the sites 5 where it is harvested and at our borders. 6 BE IT FURTHER RESOLVED that the Legislature of Louisiana hereby requests that 7 the United States require every lot of imported seafood to enter our border with a full lab 8 certificate ensuring compliance with our food and drug laws. 9 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 10 presiding officers of the Senate and the House of Representatives of the Congress of the
