PUBLIC RECORDS: Provides relative to interagency data sharing

1	AN ACT
2	To enact Chapter 15-A of Title 49 of the Louisiana Revised Statutes of 1950, to be
3	comprised of R.S. 49:1061, relative to interagency data sharing; to provide for a data
4	sharing review board; to provide for data sharing authorization; and to provide for
5	related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. Chapter 15-A of Title 49 of the Louisiana Revised Statutes of 1950,
8	comprised of R.S. 49:1061, is hereby enacted to read as follows:
9	CHAPTER 15-A. DATA SHARING REVIEW
10	<u>§1061. Data sharing review</u>
11	A. A state agency requesting data from another state agency may petition the
12	joint committee on governmental affairs to conduct a review of the agency's request
13	for data sharing to gain authorization by the committee for the data to be shared
14	between the agencies.
15	B.(1) The requesting agency shall send a petition in writing to both the
16	House and Senate committees on governmental affairs. The request shall include the
17	following information:
18	(a) The receiving or requesting agency and the disclosing agency.
19	(b) Scope of data being requested.
20	(c) Scope of use, including who will have access to the data.

2	(e) Legal authority for the transfer.		
3	(2)(a) Upon receipt of the agency's petition, the joint committee on		
4	governmental affairs may conduct a hearing to approve the agency's request for the		
5	data to be shared.		
6	(b) The joint committee on governmental affairs shall notify the agencies of		
7	the scope of the public meeting regarding the agency's request for data.		
8	C.(1) Each state agency may cooperate with the House and Senate		
9	committees on governmental affairs in fulfilling the requirements of this Section.		
10	(2) Upon the approval by the joint committee on governmental affairs of the		
11	agency's request for data, the disclosing agency may provide the data to the		
12	requesting agency.		
13	D. Nothing in this Section shall supersede the provisions of R.S. 47:1508 or		
14	any other provisions of law that provide for confidentiality of information.		
15	Additionally, nothing in this Section shall require an agency to provide information		
16	which it is contractually obligated to keep confidential.

Abstract: Allows data sharing authorization by the joint committee on governmental affairs.

<u>Proposed law</u> allows a state agency to request a public meeting before the joint committee on governmental affairs regarding the agency's request for data from another state agency.

<u>Proposed law</u> allows the joint committee on governmental affairs to authorize the data sharing request.

<u>Proposed law</u> provides that <u>proposed law</u> does not supersede other provisions of law or contractual obligations requiring confidentiality of information.

Summary of Amendments Adopted by House

- The Committee Amendments Proposed by <u>House Committee on House and</u> <u>Governmental Affairs</u> to the <u>original</u> bill:
- 1. Change provision regarding state agency cooperation with the House and Senate committees on governmental affairs in fulfilling the requirements of <u>proposed</u> <u>law</u> to make it permissive rather than mandatory.
- 2. Add a provision that <u>proposed law</u> does not supersede provisions of law or contractual obligations requiring confidentiality of information.
