Proposed law suspends provisions of present law, relative to the restriction of the amount of funds used by the Department of Culture, Recreation and Tourism for the purchase of in-state media advertisement.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed concurrent resolution suspends the cap of 10% of all funds used to purchase media advertisement that are used on in-state media purchases. The Department of Culture Recreation and Tourism reports this provision will not impact the expenditure budget for the Office of Tourism, but will allow it to expend a greater portion of its media allocation on in-state media advertising.
