

**SENATE FLOOR AMENDMENTS**

2020 Regular Session

Amendments proposed by Senator Cortez to Engrossed House Bill No. 202 by Representative Horton

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S." delete the remainder of the line and insert the following:

3 "47:1525(A), (B)(1)(introductory paragraph), (2)(a)(introductory paragraph), and (b),  
4 to enact R.S. 47:1525(B)(1)(i), (j), (k), (l) and (6), and to repeal R.S. 47:1525(B)(1)(d),"

5 AMENDMENT NO. 2

6 On page 1, delete lines 3 through 5 and insert "relative to the Louisiana Tax Institute;"

7 AMENDMENT NO. 3

8 On page 1, line 8, after "Section 1. R.S." delete the remainder of the line and delete line 9  
9 and insert the following:

10 "47:1525(A), (B)(1)(introductory paragraph), (2)(a)(introductory paragraph), and (b)  
11 are hereby amended and reenacted and R.S. 47:1525(B)(1)(i), (j), (k), (l) and (6) are  
12 hereby enacted to read as follows:"

13 AMENDMENT NO. 4

14 On page 1, delete line 11 and insert the following:

15 "A. There is hereby established within the ~~Department of Revenue~~ **legislature** the  
16 Louisiana Tax Institute, hereinafter referred to as "Institute" which shall be a public  
17 body and shall serve as the official advisory tax law revision and tax law reform  
18 agency of the state of Louisiana."

19 AMENDMENT NO. 5

20 On page 1, delete line 20 and insert the following:

21 **"(1) One member appointed by the Secretary of State, or his designee.**

22 (2)(a) Except for the secretary of the Department of Revenue, ~~and the governor's~~  
23 ~~designee; and the members appointed by the speaker of the House of~~  
24 **Representatives and the president of the Senate**, all members of the board shall  
25 serve three-year terms, except for initial terms which shall be determined by lot at  
26 the first meeting of the board as follows:

28 (b) The secretary of the Department of Revenue, ~~and the governor's designee~~ **and**  
29 **the members appointed by the speaker of the House of Representatives and**  
30 **the president of the Senate** shall serve during the duration of their appointment  
31 to those positions ~~by the governor.~~

33 **(6) The speaker of the House of Representatives and the president of the**  
34 **Senate shall determine and designate the chairman of the governing board of**  
35 **the Institute.**

4 AMENDMENT NO. 7

5 On page 2, between lines 4 and 5, insert the following:

6 "Section 2. R.S. 47:1525(B)(1)(d) is hereby repealed in its entirety."

7 AMENDMENT NO. 8

8 On page 2, line 5, change "Section 2." to "Section 3."
