A RESOLUTION

2	To express sincere and heartfelt condolences upon the death of Ernest D. Wooton, former
3	state representative and former sheriff of Plaquemines Parish.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	Louisiana House of Representatives have learned of the death of Ernest D. Wooton, former
6	state representative and former sheriff of Plaquemines Parish, on May 29, 2020, at the age
7	of seventy-eight, in Belle Chasse, Louisiana; and
8	WHEREAS, a native of Plaquemines Parish and a graduate of Port Sulphur High
9	School, Ernest Wooton attended Louisiana State University and Northwestern State
10	University; after serving in the United States Army from 1964 until 1966, he was an
11	insurance agency manager and then worked in public relations for oilfield sales; and
12	WHEREAS, Mr. Wooton began his long and productive career in public service in
13	1984 with his election as sheriff of Plaquemines Parish; during his two terms as sheriff, he

1	was admired for his highly effective leadership and made many significant contributions to
2	the community, including founding the Plaquemines Parish sheriff's office shooting
3	range/junior deputy grounds in Myrtle Grove and establishing the Special Olympics in the
4	parish; and
5	WHEREAS, following his service as sheriff, Ernest Wooton became a widely
6	respected legislator, serving with excellence as the state representative for District No. 105
7	from 1999-2012, during which time he fully used every opportunity to serve the citizens of
8	his district and the state in an honorable and dedicated manner; and
9	WHEREAS, Representative Wooton's diligent committee service included serving
10	as chairman of the House Committee on Administration of Criminal Justice, as vice
11	chairman of the House Committee on Environment, and as a member of the House
12	Committee on Homeland Security and the Joint Committee on Homeland Security; he also
13	served as a member of the Acadiana Delegation, the Jefferson Parish Legislative Delegation,
14	and the Louisiana Rural Caucus; and
15	WHEREAS, during his time in the House of Representatives, Representative Wooton
16	worked on and supported many important pieces of legislation, was a steadfast advocate for
17	law enforcement, education, and coastal restoration issues, and was unwavering in his efforts
18	to improve the welfare of his constituents in Plaquemines, Jefferson, and St. Charles
19	parishes; and
20	WHEREAS, throughout the halls of the state capitol, Representative Wooton was
21	known as a man of his word who had a special talent for diffusing tense moments during
22	legislative proceedings with his trademark humor and as a representative who accomplished
23	much by the sheer force of his own personal credibility and integrity; and
24	WHEREAS, though Mr. Wooton maintained a somewhat tough exterior, he was a
25	man of compassion and concern for his fellow man; he cared about those he served with in
26	the legislature regardless of their political affiliation and was a source of solid support and
27	advice to his colleagues and staff; and
28	WHEREAS, in 2011, Sheriff Wooton was inducted into the Louisiana Justice Hall
29	of Fame, which was founded to recognize individuals who have served the state of Louisiana
30	in law enforcement, corrections, criminal justice, and civil service with great distinction; and

1 WHEREAS, a truly beloved member of his community, Mr. Wooton was a member 2 of the American Legion, Knights of Columbus, and Alcoholics Anonymous, and he took 3 great pride in his twenty-seven years of sobriety; and 4 WHEREAS, Ernest Wooton was patriotic to the core and was passionate when 5 expressing his love and appreciation for America and her ideals and when reminding others 6 of the debt of gratitude owed to all who have served and fought for this country; and 7 WHEREAS, above all, Ernest Wooton was a family man who loved spending time 8 with his wife, children, and grandchildren; he enthusiastically attended their graduations, 9 baseball games, dance recitals, and other activities, often traveling to support them and cheer 10 for them in their endeavors; he left an indelible mark not only on their lives but on the lives 11 of all who knew and loved him and were touched by his loyalty, charisma, great wit, abiding 12 faith, strength of character, and generosity of spirit; and 13 WHEREAS, Mr. Wooton is survived by his wife of fifty-three years, Linda Green 14 Wooton; his children, Jeffrey J. Wooton, and his wife Peggy, Kimberly Wooton Culpepper, 15 and her husband Marvin, and John Dade Wooton, and his wife Therese; his grandchildren 16 and step-grandchildren, Jacob Wooton, Gavin Culpepper, and his wife Averi, Bailey 17 Culpepper, John Dade Wooton II, Ella Wooton, Blake Culpepper, Megan Torres, and her 18 husband Gus, and Erin Ness; his great-grandson and step-great-grandchildren; Ace 19 Culpepper, Tyler Elmer, Riley Elmer, Cruz Torres, and Chloe Torres; and his sister, JoAnn 20 Wooton Defley; and 21 WHEREAS, with the death of Ernest Wooton, the state has lost one of her finest 22 sons, a man who will be remembered by all who were lucky enough to know him, including 23 the members of the House family, all of whom mourn the loss of this wonderful man who 24 served this institution and this state so well. 25 THEREFORE, BE IT RESOLVED that the House of Representatives of the 26 Legislature of Louisiana does hereby express sincere and heartfelt condolences upon the 27 death of Ernest D. Wooton, former state representative and former sheriff of Plaquemines 28 Parish; does hereby recognize and record for posterity his notable accomplishments and 29 singular contributions during his tenure as a distinguished member of the Louisiana House
