2	To authorize and direct the Louisiana State Law Institute to study and make
3	recommendations to the Legislature of Louisiana regarding language in the
4	Constitution of Louisiana that is outdated or transitional in nature and which can be
5	removed or updated without affecting the effect of the constitutional provisions.
6	WHEREAS, it has been more than forty-five years since the Constitution of
7	Louisiana became effective at midnight on December 31, 1974, and during these years the
8	document which constitutes the state's basic law has been amended some one hundred
9	ninety-seven times; and
0	WHEREAS, the language of the Constitution of Louisiana has not been studied
1	broadly since it became effective and the legislature recognizes the importance for legal
12	scholars to review the language to determine if there are updates or modifications to the
13	language that should be made without changing the meaning and effect of the law.
14	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
15	authorize and direct the Louisiana State Law Institute to study and make recommendations
16	to the Legislature of Louisiana regarding language in the Constitution of Louisiana that is
17	outdated or transitional in nature and which can be removed or updated without affecting the
18	effect of the constitutional provisions.
19	BE IT FURTHER RESOLVED that the Louisiana State Law Institute should further
20	identify language in the constitution that is legally unnecessary, redundant, or obsolete;
