3	potential data points that are collected or are capable of being collected by the
4	Department of Economic Development and to provide a written report of its findings
5	to the House Committee on Ways and Means no later than February 1, 2021.

14	historical comparisons and analysis that require many data points in order to be useful; and

16	purpose of analytics is pertinent to the legislature for policy-making decisions that affect the
17	entire state; and
18	WHEREAS, accessing all relevant data points that are collected, as well as all
19	traceable data points that are capable of being collected, will assist the legislature in policy-
20	making decisions that affect the entire state.
