Provides for the establishment of a special advisory committee for the purposes of reapportionment.

The proposed resolution creates the Special Advisory Committee for Reapportionment to study and make recommendations to the legislature prior to March 1 of each year ending in one. The committee shall be comprised of the 18 members; and have the power of a standing committee of either legislative body to hold hearings and do all other things necessary to discharge its duties. The committee may request staff of any department, agencies, and officials to assist, and the President of the Senate and Speaker of the House shall designate staff to assist the committee. It further provides that the organizational meeting is held no later than August 15 of each year ending. The committee shall dissolve no later than December 31 of each year ending in one. Members of the committee shall serve without compensation from the legislature.
