| 8 | Section 1. R.S. 17:176(G) is hereby enacted to read as follows: |

| 10 | prohibitions; filming or videotaping; definitions |

| 12 | G.(1) Notwithstanding any other law to the contrary, no public school or |
| 13 | nonpublic school that receives public funds may be a member of, or participate |
| 14 | in any competition sponsored by, any intrastate interscholastic extracurricular |
| 15 | athletic association or organization that does not provide for the following |
| 16 | persons to serve as members of its executive committee, board of directors, or |
| 17 | other governing board: |

| 1 | (a) The president of the Senate or his designee. |

| 10 | complied with the provisions of this Subsection by January 15, 2021. |
| 11 | Section 2. This Act shall become effective upon signature by the governor or, if not |
| 12 | signed by the governor, upon expiration of the time for bills to become law without signature |
| 13 | by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If |
| 14 | vetoed by the governor and subsequently approved by the legislature, this Act shall become |
| 15 | effective on the day following such approval. |

Proposed law provides that no public or nonpublic school that receives public funds may be a member of, or participate in any competition sponsored by, any intrastate interscholastic extracurricular athletic association or organization that does not provide for the president of the Senate, the speaker of the House, and the chairmen of the Senate and House committees on education, or their designees, to serve as members of the organizations executive committee, board of directors, or other governing board. Further provides that these

members shall be afforded all the privileges and voting rights prescribed for all members.

Effective upon signature of the governor or lapse of time for gubernatorial action.
