7 On page 2, line 8, change "petition terminating" to "**termination of**"

8 AMENDMENT NO. 4

9 On page 2, at the end of line 10, insert the following:

10 **"The termination shall be approved by concurrent resolution if the legislature**  
11 **is in session. The termination may be completed by mail ballot or petition if the**  
12 **legislature is not in session. If a period of time is established during which no**  
13 **other declaration may be issued, it shall not exceed thirty days. Either form of**  
14 **the petition shall be offered by the chairman of the Legislative Emergency**  
15 **Declaration Review Committee after a hearing pursuant to Subsection I of this**  
16 **Section, wherein the committee upon majority vote recommends to terminate**  
17 **the emergency declaration. The procedure, transmittal, and receipt of mail**  
18 **ballots shall be the same as La. R.S. 39:461.1."**

19 AMENDMENT NO. 5

20 On page 4, at the end of line 1, insert the following:

21 **"Nothing in this Subsection shall prohibit the governor from making**  
22 **modifications, additions, or corrections to the order, proclamation, or**  
23 **suspension after submission of the notification to the committee. The governor**  
24 **shall submit any modifications, additions, or corrections to the order,**  
25 **proclamation, or suspension to the committee before issuance."**

6 **other declaration may be issued, it shall not exceed thirty days. Either form of**  
7 **the petition shall be offered by the chairman of the Legislative Emergency**  
8 **Declaration Review Committee after a hearing pursuant to this Subsection C**  
9 **of this Section, wherein the committee upon majority vote recommends to**  
10 **terminate the emergency declaration. The procedure, transmittal, and receipt**  
11 **of mail ballots shall be the same as La. R.S. 39:461.1."**
