SENATE BILL NO. 41

BY SENATOR JOHNS

FEES/LICENSES/PERMITS. Provides relative to provisional licenses issued by the state fire marshal. (gov sig) (Item #32)

1 AN ACT

2 To enact R.S. 40:1664.8(I), relative to the state fire marshal; to provide for the provisional
3 licensure of certain applicants; to provide for the revocation of a provisional license;
4 to provide for terms, conditions, and procedures; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 40:1664.8(I) is hereby enacted to read as follows:

7 §1664.8. Criminal background checks; provisional license

8 * * *

9 **I.(1) The state fire marshal may issue a provisional license to a property**
10 **protection applicant for a period not to exceed sixty days from the date of**
11 **issuance while verification of the applicant's criminal history is pending. The**
12 **issuance of this provisional license is contingent upon the applicant's attestation**
13 **that he has never been convicted of a felony, received a first-time offender**
14 **pardon for a felony, or entered a plea of guilty or nolo contendere to a felony**
15 **charge. Any person with a provisional license issued pursuant to this Subsection**
16 **shall work under the direct supervision and accompaniment of a technician who**
17 **is licensed to the same firm and holding a valid license to perform the same acts.**

1 **(2) The fire marshal shall revoke the provisional license issued pursuant**
 2 **to Paragraph (1) of this Subsection if the applicant fails to pass the criminal**
 3 **background check or is in violation of R.S. 14:133.**

4 Section 2. The provisions of this Act shall become effective upon signature by the
 5 governor or, if not signed by the governor, upon expiration of the time for bills to become
 6 law without signature by the governor, as provide by Article III, Section 18 of the
 7 Constitution of Louisiana. If vetoed by the governor and subsequently approved by the
 8 legislature, the provisions of this Act shall become effective on the day following such
 9 approval.

Present law provides relative to the Life Safety and Property Protection Act.

Present law provides for the licensure and regulation of a person or firm engaged in life safety and property protection contracting by the state fire marshal.

Present law provides for criminal background checks on persons applying for a property protection license.

Proposed law retains present law and authorizes the state fire marshal to issue a provisional license to a property protection applicant for a period not to exceed 60 days from issuance while verification of their criminal history is pending. Proposed law provides that to be issued a provisional license, the applicant must attest that he has never been convicted of a felony, received a first-time offender pardon for a felony, or entered into a plea of guilty or nolo contendere to a felony charge and the work under the direct supervision and accompaniment of a technician who is licensed to the same firm and holds a valid license to perform the same acts.

Proposed law requires the fire marshal shall revoke the provisional license if the applicant fails to pass the criminal background check or files a false public record.

Effective upon signature of the governor or lapse of time for gubernatorial action.
