TRAFFIC: Urges and requests the Department of Transportation and Development to study issues relating to traffic management along Louisiana Highway 16 in certain areas of Denham Springs, Louisiana

1	A RESOLUTION
2	To urge and request the Department of Transportation and Development to conduct a study
3	and make recommendations relative to implementing innovative traffic management
4	methods along Louisiana Highway 16 in Denham Springs, Louisiana, near Live Oak
5	High School.
6	WHEREAS, Live Oak High School is a part of the Livingston Parish School System
7	and relocated to 36079 Louisiana Highway 16 in Denham Springs, Louisiana, in 2012 to
8	accommodate an increase in students, with over thirteen hundred students enrolled; and
9	WHEREAS, Louisiana Highway 16 is a two-lane highway with traffic congestion
10	that increases dramatically during the hours of arrival and dismissal at Live Oak High
11	School; and
12	WHEREAS, as the population continues to increase a corresponding increase in
13	traffic and accidents can be anticipated; and
14	WHEREAS, it is prudent that the Department of Transportation and Development
15	conduct a traffic study to determine innovative traffic management methods to decrease the
16	traffic on Louisiana Highway 16 near Live Oak High School, particularly during the school
17	year.
18	THEREFORE, BE IT RESOLVED that the House of Representatives of the
19	Legislature of Louisiana does hereby urge and request the Department of Transportation and
20	Development to conduct a study and make recommendations relative to implementing

- to the House Committee on Transportation, Highways and Public Works by March 1, 2021.
