CORRECTIONS/PRISONERS: Requests the Department of Public Safety and Corrections to reconvene the COVID-19 Furlough Review Panel

1	A RESOLUTION
2	To urge and request the Department of Public Safety and Corrections to reconvene the
3	COVID-19 Furlough Review Panel to safely reduce the potential risk of COVID-19
4	in Louisiana's prisons and jails.
5	WHEREAS, on April 14, 2020, the Department of Public Safety and Corrections
6	created the COVID-19 Furlough Review Panel to consider certain offenders, who were
7	within the last six months of their prison sentence, for temporary furloughs; and
8	WHEREAS, the Department of Public Safety and Corrections, along with the
9	probation and parole office of the Department of Public Safety and Corrections, the
10	Louisiana District Attorneys Association, the Louisiana Sheriffs' Association, and Louisiana
11	courts, implemented measures to help reduce the spread of COVID-19 throughout the
12	criminal justice system; and
13	WHEREAS, the COVID-19 Furlough Review Panel aimed to reduce the population
14	of offenders sentenced to the custody of the Department of Public Safety and Corrections
15	in a way that maintained public safety and promoted public health; and
16	WHEREAS, as of October 20, 2020, the Department of Public Safety and
17	Corrections reported a total of two thousand four hundred five positive COVID-19 cases;
18	and
19	WHEREAS, it is necessary for the panel to reconvene to consider any person
20	sentenced to the custody of the Department of Public Safety and Corrections and within six
21	months of discharge to be eligible for temporary furloughs.

1 THEREFORE, BE IT RESOLVED that the House of Representatives of the

- 2 Legislature of Louisiana does hereby urge and request the Department of Public Safety and
- 3 Corrections to reconvene the COVID-19 Furlough Review Panel to safely reduce the
- 4 potential risk of COVID-19 in Louisiana's prisons and jails.
- 5 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
- 6 secretary of the Department of Public Safety and Corrections.
