PROPERTY/PUBLIC: Provides relative to the exchange of certain property between the University of Louisiana System and the City of Lafayette

1	AN ACT
2	To authorize and provide for the transfer of certain public property; to authorize the
3	exchange of certain public property in Lafayette Parish; to provide for the property
4	description; to provide for reservation of mineral rights; to provide terms and
5	conditions; to provide an effective date; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. The Board of Supervisors for the University of Louisiana System,
8	notwithstanding any other provision of law to the contrary, is hereby authorized and
9	empowered to convey, transfer, assign, lease, or deliver any interest, excluding mineral
10	rights, the board of supervisors may have to all or any portion of the following described
11	parcel of property to the City of Lafayette for the property described in Section 2 of this Act:
12 13 14 15 16 17 18 19 20 21 22 23	That certain tract or parcel of ground, together with all buildings and improvements thereon and thereunto belonging, situated in Section 68, Township 9 South, Range 4 East, City and Parish of Lafayette, Louisiana, containing 2.10 acres, more or less, and having an approximate frontage of 447 feet on Cajundome Blvd., by a depth along the northwesterly boundary of approximately 181 feet, a depth along the northerly boundary of approximately 152 feet, and a southerly boundary of approximately 59 feet, bounded westerly by Cajundome Blvd., northerly, northwesterly and southerly by other property of the Board of Supervisors for the University of Louisiana System, and easterly by the center line of the Coulee, all as more particularly shown on that sketch attached hereto and mad a part hereof as Exhibit "A".
24	Section 2. In exchange for the above described property in Section 1, the Board of
25	Supervisors for the University of Louisiana System, notwithstanding any other provision of

1 law to the contrary, is hereby authorized and empowered to accept, in addition to any other

2 consideration, delivery of title to all or any portion of the following described parcels of

3 property from the City of Lafayette:

4 That certain tract or parcel of ground, together with all buildings and 5 improvements thereon, situated in Section 48, Township 10 South, Range 4 6 East, City and Parish of Lafayette, Louisiana, and being more particularly 7 known as the City of Lafavette Fire Station No. 5, and being that said tract 8 or parcel of ground situated between the letters A, B, C, D, N, O, P, and A, 9 and having further measurements and boundaries, dimension, shape, form, 10 and location as is more fully shown on that Plat of Survey prepared by Craig 11 P. Spikes, RLS No. 4580, dated July 25, 2012, attached to act recorded under 12 Entry No. 2012-29757 of the records of the Lafayette Parish Clerk of Court's 13 Office.

14 Section 3. The Board of Supervisors for the University of Louisiana System and the 15 governing authority for the City of Lafayette are hereby authorized to enter into such 16 agreements, covenants, conditions, and stipulations and to execute such documents as 17 necessary to properly effectuate any conveyance, transfer, assignment, lease, or delivery of 18 title, excluding mineral rights, to the property described in Sections 1 and 2 of this Act, and 19 as more specifically described in any such agreements entered into and documents executed 20 by and between the Board of Supervisors for the University of Louisiana System and the 21 City of Lafayette, in exchange of consideration proportionate to the appraised value of the 22 property. 23 Section 4. This Act shall become effective upon signature by the governor or, if not 24 signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If 25

- 26 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 27 effective on the day following such approval.
