Provides relative to required instruction in American history and civics in public schools

Proposed legislation provides additions to the list of topics on which public schools must provide information as part of required instruction on the Founding Principles of the United States of America. Instruction must include: (1) The Declaration of Independence; (2) The Constitution; (3) The Federalist Papers; (4) The Gettysburg Address; (5) National sovereignty; (6) American exceptionalism; (7) Globalism and the United Nations; and (8) Immigration policy. Requires the provision of age and grade appropriate instruction in civics to public school students in grades Kindergarten through 8. Provides that such instruction may be incorporated into an existing course. Requires that textbooks and materials used in the instruction accurately reflect an understanding of the history and values of the people of the United States and Louisiana. Repeals existing statute requiring study of the Declaration of Independence in elementary schools and the Federalist Papers in high schools.
