HOUSE CONCURRENT RESOLUTION NO. 34

MEDICAID: Requests a study regarding potential means of financing dental care for adult residents of intermediate care facilities

1	A CONCURRENT RESOLUTION
2	To urge and request the Louisiana Department of Health to study potential means of
3	financing dental care for adult residents of intermediate care facilities for persons
4	with intellectual and developmental disabilities and to report findings of the study
5	to the House Committee on Appropriations, the Senate Committee on Finance, and
6	the legislative committees on health and welfare.
7	WHEREAS, people with disabilities are treasured members of our families and
8	communities; and
9	WHEREAS, the legislature works to foster a culture of inclusion and equal access
10	to services for people with disabilities in our state; and
11	WHEREAS, intermediate care facilities for persons with intellectual and
12	developmental disabilities, known commonly as ICF/DD and ICF/ID, are residential
13	facilities at which children and adults with special needs receive individualized health care
14	and habilitation services; and
15	WHEREAS, state regulations concerning Medicaid funding of ICF/ID (LAC
16	50:VII.30101 et seq.) provide for a system of per diem payments to these facilities, which
17	payments fund care and services for facility residents who are Medicaid enrollees; and
18	WHEREAS, Medicaid-enrolled children and Medicaid-enrolled adults up to age
19	twenty-one residing in ICF/ID have access to Medicaid-funded health coverage that includes
20	dental services, but Medicaid-enrolled adults age twenty-one and older residing in such
21	facilities do not; and

WHEREAS, routine and preventive dental care is important to a person's overall 2 health, and many states have found that investing in preventive dental care for Medicaid 3 enrollees saves public dollars on a net cost basis by preventing emergency room visits and 4 expensive, complicated treatments arising from neglect of oral health; and

5 WHEREAS, policymakers in Louisiana have heretofore overlooked the necessity of 6 providing dental coverage for adults with intellectual and developmental disabilities, a cause 7 for which advocates for this population have been fighting for many years; and

8 WHEREAS, neglecting the oral health of persons with intellectual and 9 developmental disabilities leads to avoidable expenditures of public funding in the form of 10 hospitalizations and oral and maxillofacial surgeries; in the case of adult ICF/ID residents, 11 Louisiana Medicaid will cover such expensive treatments, but not the lower-cost routine care 12 that would prevent those expensive treatments from becoming necessary; and

13 WHEREAS, policymakers should consider not only the cost impact of continuing 14 to deny Medicaid coverage for routine dental care for adult ICF/ID residents, but also the 15 pain that these persons endure, often without the capacity to understand or communicate 16 verbally about their condition, and the hardships that their family members and other 17 caregivers go through when they have to be hospitalized or have oral surgery due to a 18 preventable oral health condition; and

19 WHEREAS, House Bill No. 172 of the 2021 Regular Session of the Legislature (HB 20 172) has proposed to institute a dental coverage requirement in the state Medicaid program 21 for all persons of age twenty-one or older who are either enrolled in a Medicaid waiver 22 program for persons with developmental or intellectual disabilities or reside in an ICF/ID facility; and 23

24 WHEREAS, the Louisiana Department of Health administers the Medicaid program 25 of this state; and

26 WHEREAS, the department has indicated that if funding is available, it could 27 provide Medicaid dental coverage for adult waiver program enrollees as proposed in HB 172; but that, even with funding availability, it could not provide the same coverage to 28 29 ICF/ID residents due to limitations relating to the way that per diem payments to these 30 facilities are structured.

1	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
2	urge and request the Louisiana Department of Health to study potential means of financing
3	dental care for adult residents of intermediate care facilities for persons with intellectual and
4	developmental disabilities.
5	BE IT FURTHER RESOLVED that the Louisiana Department of Health shall report
6	findings of the study called for in this Resolution to the House Committee on
7	Appropriations, the Senate Committee on Finance, the House Committee on Health and
8	Welfare, and the Senate Committee on Health and Welfare no later than sixty days prior to
9	the convening of the 2022 Regular Session of the Legislature of Louisiana.
10	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
11	secretary of the Louisiana Department of Health.
