24 The net income of a nonresident individual or a corporation subject to the tax 25 imposed by this Chapter shall be the sum of the net allocable income earned within 26 or derived from sources within this state, as defined in R.S. 47:243, and the net 27 apportionable income derived from sources in this state, as defined in R.S. 47:244, less the amount of federal income taxes attributable to the net allocable income and 28 29 net apportionable income derived from sources in this state. The amount of federal 30 income taxes to be so deducted shall be that portion of the total federal income tax 31 which is levied with respect to the particular income derived from sources in this state to be computed in accordance with rules and regulations of the collector of 32 33 revenue. Proper adjustment shall be made for the actual tax rates applying to

different classes of income and for all differences in the computation of net income for purposes of federal income taxation as compared to the computation of net income under this Chapter. Where the allocation of the tax is to be based on a ratio of the amount of net income of a particular class, both the numerator and the denominator of the fraction used in determining the ratio shall be computed on the basis that such net income is determined for federal income tax purposes."

10 "(3) "Excess federal itemized personal deductions" for the purposes of this 11 Part, means the following percentages of the amount by which the federal itemized 12 personal deductions exceed the amount of federal standard deductions which is 13 designated for the filing status used for the taxable period on the individual income 14 tax return required to be filed:

- (a) For tax years beginning during calendar year 2007, fifty-seven and one
 half percent of such excess federal itemized personal deductions.
- (b) For tax years beginning during calendar year 2008, sixty-five percent of
 such excess federal itemized personal deductions.

(c) For all tax years beginning on and or after January 1, 2009, but before January 1, 2022, one hundred percent of such excess federal itemized personal deductions.

- (d) For tax years beginning on or after January 1, 2022, no deduction of
 excess federal itemized personal deductions shall be allowed on state individual
 income tax returns."
