6	Louisiana has learned of the untimely death, on April 10, 2021, of Bradley Dewayne Cryer,
7	assistant legislative auditor and director of local government services; and
8	WHEREAS, Bradley devoted twenty-five years of his life to the service of state and
9	local government; he performed governmental audits, advised local governments and
10	certified public accountants, and served as a speaker to governmental groups and
11	professional associations to promote accountability and transparency in government; and
12	WHEREAS, Bradley was a highly qualified and accomplished professional; he
13	received a bachelor of science degree in accounting from Louisiana Tech University and was
14	a certified public accountant and chartered global management accountant; and
15	WHEREAS, Mr. Cryer also held membership in a variety of associations, including
16	the American Institute of Certified Public Accountants, the Louisiana Society of Certified
17	Public Accountants, and the Government Finance Officers Association; and
18	WHEREAS, during his tenure with the Louisiana Legislative Auditor's office,
19	Bradley Cryer served in various capacities and positions; from 1996-2008, he worked as a
20	staff and senior auditor in financial audit services; from 2008-2010, he served as manager
21	of financial audit services; from 2010-2016, he served as the assistant director of financial

1 audit services; and from 2016 until his passing, he served as an assistant legislative auditor 2 and director of local government services; and 3 WHEREAS, in his personal time, Bradley enjoyed a variety of outdoor activities, 4 including hunting and fishing; he also loved listening to music and was a devoted husband, 5 father, son, brother, and friend; and 6 WHEREAS, Bradley is survived by his loving wife, Mary Ann Cryer; his children, 7 Dyland Cryer, Jennifer Peterson, and Hannah Peterson; his parents, Jerry and Linda Midkiff 8 Cryer; his sister, Wendy Squires, and her husband Henry; his brother-in-law, Carl "C.B." 9 Barnett, and his wife Lisa; his maternal grandmother, Lena Midkiff; and many friends and 10 professional colleagues; and 11 WHEREAS, Mr. Cryer was a truly devoted public servant, and he will be deeply 12 missed. 13 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 14 express heartfelt condolences on the death of Bradley Dewayne Cryer, assistant legislative 15 auditor and director of local government services; does hereby recognize Bradley's twenty-16 five years of dedicated services to the people of Louisiana and the legislature; and does 17 hereby extend sincere hopes that his family and friends find comfort during this extremely 18 difficult time. 19 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 20 family of Bradley Dewayne Cryer.
