SENATE RESOLUTION NO. 207

FISCAL CONTROLS. Authorizes the establishment of a subcommittee of the Committee on Finance to study Louisiana Workforce Commission administration of the federal unemployment compensation program.

2	To authorize the establishment of a subcommittee of the Committee on Finance to conduct		
3	a study and review of the federal unemployment program administered by the		
4	Louisiana Workforce Commission, particularly during the coronavirus pandemic.		
5	WHEREAS, the legislative auditor has cited concerns about the administration of the		
6	state's unemployment program during the early days of the coronavirus pandemic, including		
7	the allocation of federal jobless benefits, state worker overtime, and the ability to securely		
8	process billions of federal tax dollars; and		
9	WHEREAS, the legislative auditor asserts that Louisiana Workforce Commission		
10	(LWC) did not have adequate internal controls and did not comply with requirements of the		
11	Unemployment Insurance (UI) federal program; and		
12	WHEREAS, the fiscal year overlaps the early onslaught of the coronavirus pandemic		
13	and lockdowns between March and June 2020 that put hundreds of thousands of		
14	Louisianians out of work during which time, the LWC handed out \$3.7 billion in		
15	unemployment benefits to 575,000 individuals; and		
16	WHEREAS, in a random sample conducted by the legislative auditor's office of 138		
17	individuals to whom \$902,822 were paid in benefits, \$261,063 were questionable as		
18	potential identify theft or fraud and in some cases were even backdated related to child care		

1 deductions; and

2	WHEREAS, there is a concern that money may be required to be returned from the
3	state for overpayments that could have been avoided or reduced with adequate state controls.
4	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
5	hereby authorizes the establishment of a subcommittee of the Committee on Finance to
6	conduct a study and review of the federal unemployment program administered by the
7	Louisiana Workforce Commission, particularly during the coronavirus pandemic.
8	BE IT FURTHER RESOLVED that the chairman of the Committee on Finance shall
9	appoint the members, as well as the chairman and vice chairman, of the subcommittee.
10	BE IT FURTHER RESOLVED that the subcommittee shall submit a report,
11	including recommendations for legislation, to the Committee on Finance by January 1, 2022.
