AN ACT

2 To enact R.S. 47:302(BB)(114), 305.75, 321(P)(115), 321.1(I)(115) and 331(V)(115) and 3 to repeal R.S. 47:337.10.2(C), relative to sales and use tax exemptions; to provide 4 for a state sales and use tax exemption for certain purchases of feminine hygiene 5 products; to provide for a state sales and use tax exemption for certain purchases of 6 diapers; to provide for definitions; to provide for the effectiveness of the optional 7 local sales and use tax exemption for certain purchases of feminine hygiene products 8 and diapers; to provide for certain requirements and limitations; and to provide for 9 related matters. 10 Be it enacted by the Legislature of Louisiana: Section 1. R.S. 47:302(BB)(114), 305.75, 321(P)(115), 321.1(I)(115), and 11 12 331(V)(115) are hereby enacted to read as follows: 13 §302. Imposition of tax 14 15 BB. Notwithstanding any other provision of law to the contrary, including 16 but not limited to any contrary provisions of this Chapter, beginning July 1, 2018, 17 through June 30, 2025, there shall be no exemptions and no exclusions to the tax 18 levied pursuant to the provisions of this Section, except for the retail sale, use, 19 consumption, distribution, or storage for use or consumption of the following: 20

5	A. The sales and use tax imposed by the state of Louisiana or any political
6	subdivision whose boundaries are coterminous with those of the state shall not apply
7	to the purchase of feminine hygiene products, diapers, or both for individual personal
8	use.
9	B. For the purposes of this Section:
10	(1) "Diaper" means any absorbent diaper or undergarment used for
11	incontinence in adults and any absorbent diaper or undergarment designed to be
12	worn by a child who cannot yet control bladder or bowel movements.
13	(2) "Feminine hygiene product" means tampons, menstrual pads, sanitary
14	napkins, panty liners, menstrual sponges, and menstrual cups, including disposable
15	and washable versions of these items.

2	signed by the governor, upon expiration of the time for bills to become law without signature
3	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
4	vetoed by the governor and subsequently approved by the legislature, this Act shall become
5	effective on the day following such approval.
