SUNSET LAW. Re-creates the Department of Environmental Quality. (6/30/22)

To enact R.S. 49:191(13)(a) and to repeal R.S. 49:191(10)(f), relative to the Department of Environmental Quality, including provisions to provide for the re-creation of the Department of Environmental Quality and the statutory entities made a part of the department by law; to provide for the effective termination date for all statutory authority for the existence of such statutory entities; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. Pursuant to R.S. 49:193, the Department of Environmental Quality and the statutory entities made a part of the department by law shall be re-created effective June 30, 2022, and all statutory authority therefore is continued in accordance with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

Section 2. All statutory authority for the existence of the Department of Environmental Quality and the statutory entities made a part of the department as re-created by Section 1 of this Act shall cease as of July 1, 2027, pursuant to R.S. 49:191. However, the Department of Environmental Quality may be re-created prior to such date in accordance with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of

<u>Present law</u> (Sunset law) provides that the Dept. of Environmental Quality and all the statutory entities made a part of that department by law must begin to terminate their operations on July 1, 2022, and that all legislative authority for such entities must cease as of July 1, 2023, unless the legislature enacts a bill authorizing the re-creation of the department and its statutory entities prior thereto.

<u>Proposed law</u> provides for the re-creation of the Dept. of Environmental Quality and its statutory entities, effective June 30, 2022, for a four-year period.
