2	To enact R.S. 32:57(J) and 239, relative to the Louisiana Highway Regulatory Act; to
3	provide relative to traffic regulations; to provide relative to speed limits; to provide
4	relative to driving on the right side, overtaking, and passing; to provide for signs; to
5	provide for penalties; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 32:57(J) and 239 are hereby enacted to read as follows:
8	§57. Penalties; alternatives to citation
9	* * *
10	J. If a person operating a motor vehicle violates the provisions of this
11	Chapter while on the Atchafalaya Basin Bridge, the fine shall be five times the
12	standard fine imposed.
13	* * *
14	§239. Atchafalaya Basin Bridge; signs
15	Notwithstanding any provision of law to the contrary, the Department
16	of Transportation and Development is hereby directed to place signs on the
17	Atchafalaya Basin Bridge as follows:

1	(1) Eight sets of speed limit signs equally spaced on the eastbound
2	portion of the Atchafalaya Basin Bridge.
3	(2) Eight sets of speed limit signs equally spaced on the westbound
4	portion of the Atchafalaya Basin Bridge.
5	(3) Six sets of "Trucks Right Lane Only" signs equally spaced on the
6	eastbound portion of the Atchafalaya Basin Bridge.
7	(4) Six sets of "Trucks Right Lane Only" signs equally spaced on the
8	westbound portion of the Atchafalaya Basin Bridge.

<u>Present law</u> provides relative to the La. Highway Regulatory Act, which includes provisions relating to speed limits and driving on the right side of the road, overtaking, and passing.

<u>Present law</u> provides for penalties for a violation of the La. Highway Regulatory Act with the first offense being a fine of not more than \$175 or imprisonment of not more than 30 days, or both, unless otherwise provided by law. A subsequent violation will result in a fine of not more than \$500 or imprisonment for not more than 90 days, or both.

<u>Proposed law</u> retains <u>present law</u> and provides that if a person operating a motor vehicle violates the provisions of <u>present law</u> while on the Atchafalaya Basin Bridge, the fine shall be five times the standard fine imposed.

<u>Present law</u> requires the Department of Transportation and Development (department) to place directional and traffic signs as required by law.

<u>Proposed law</u> requires the department to place signs on the Atchafalaya Basin Bridge as follows:

- (1) Eight sets of speed limit signs equally spaced on the eastbound portion of the Atchafalaya Basin Bridge.
- (2) Eight sets of speed limit signs equally spaced on the westbound portion of the Atchafalaya Basin Bridge.
- (3) Six sets of "Trucks Right Lane Only" signs equally spaced on the eastbound portion of the Atchafalaya Basin Bridge.
- (4) Six sets of "Trucks Right Lane Only" signs equally spaced on the westbound portion of the Atchafalaya Basin Bridge.

Effective August 1, 2022.
