R.S. 44:4.1(B)(8) is hereby amended and reenacted to read as follows: 22 §4.1. Exceptions 23 24 B. The legislature further recognizes that there exist exceptions, exemptions, and limitations to the laws pertaining to public records throughout the revised 25 statutes and codes of this state. Therefore, the following exceptions, exemptions, and 26 27 limitations are hereby continued in effect by incorporation into this Chapter by citation: 28

Section 3. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

<u>Present law</u> requires the Louisiana Public Defender Board to develop rules that ensure data is collected and maintained in a uniform and timely manner to allow the board sound data to support its resource needs.

<u>Proposed law</u> retains <u>present law</u> and further provides that raw data collected pursuant to these rules is considered confidential and not subject to the public records law.

Effective upon signature of the governor or lapse of time for gubernatorial action.
