Abstract: Requires certain school employees and volunteers to complete an annual education program on sudden cardiac arrest.

<u>Proposed law</u> requires each public school nurse, coach, athletic trainer, and athletic director, whether employed or serving as a volunteer, to complete annually a sudden cardiac arrest education program developed by the state Dept. of Education (DOE). Authorizes DOE to use materials from nonprofit organizations with missions related to cardiac health in developing the program. Requires DOE to make the program available on its website for any school or person to access free of charge.

(Adds R.S. 17:440.2 and 3996(B)(67))

- 1. Remove requirement for cardiac health instruction for students.
